Synopsis of Canadian Northwest Land Regulations

THE sole head of a family or any male over eighteen years old, may homestead a quarter-section of available Dominion land in Manitoba, Saskatchewan or Alberta. Applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the District. Entry by proxy may be made at any Dominion Lands Agency but not Sub-Agency on certain conditions. Duties.—Six months residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres, on certain conditions. A habitable house is required except where residence is performed in the vicinity. In certain districts a homesteader in good standing may pre-empt a quarter-section alongside his homestead. Price \$200 per acre. Duties Six months residence in each of three years after earning homestead patent; also 30 acres extra cultivation. Pre-emption patent may be obtained as soon as homestead patent, on certain conditions. A settler who has exhausted his homestead right may take a purchased homestead in certain districts. Price \$3.00 per acre. Duties.—Must reside six months in each of three years, cultivate 20 acres and erect a house worth \$300. The area of cultivation is subject to reduction in case of rough, scrubby or stony land. Live stock may be substituted for cultivation under certain conditions. W. W. CORY, C. M. CROSS CHANNEL IN HALF HOUR

LONDON, Aug. 26.—A big British airplane carrying its crew and nine passengers has made the trip from France to England, it is announced here. The whole journey from an airdrome in the interior of France to one in the interior of England occupied but little over half an hour. The test was made under routine conditions, with an ordinary service airplane of the largest type. The passengers carried the normal amount of baggage as they would if they had traveled by train or boat.

An event of more than ordinary interest took place at the residence of Angus McPhee, New Haven on Saturday evening August 10th when their spacious dwelling was packed to the utmost capacity to welcome back the returned hero, Willie Gass. He served four months in the trenches and was wounded in the battle of Paschendaele. He was amongst the first to cross for France with the 105th. The meeting was brought to order by Mr. Angus McPhee in a few well chosen words of welcome to the returned hero. Miss Marjory Darach then read the address of welcome and Miss Katie McPhee presented him with a gold watch and fob. Although Mr. Gass was taken by surprise thanked the donors very feelingly for their kind gift. He then gave a brief talk on the war. The following gentlemen were then called upon to speak. Mr. Pope Newman, James Tierney, John Devereaux, M. McKinnon and chairman, who gave short addresses. Music and singing was furnished by the young ladies after which the company sat down to a dainty repast of ice cream, cake, coffee and sandwiches. Great credit is due to those who responded so generously towards the donation, also the two ladies who made the appeal for who could refuse such fair solicitors, and would refuse to aid such a worthy object. After wishing the returned hero every good fortune and prosperity, the happy meeting was brought to a close by singing the National Anthem. The following is the address: Private Wm. Gass.—Returned Hero We have met here this evening in honor of your return from the war to show in a small measure one appreciation of your bravery in sacrificing home and comfort to risk your life and do your bit in this great struggle for right and liberty. That you may be restored to your usual good health and that when peace is proclaimed you will be able to participate in the glory of the victory which you have helped to win. Mrs. Margaret Cobb Harvey, wife of the late John Harvey, passed away quietly at her home in Cape Traverse, just five months after the death of her husband. FOOD BOARD FLASHES FOR FEMINE FOLK

The development of apple scab has been encouraged at Nova Scotia on account of the rain during July, and, except in orchards that have been kept thoroughly sprayed, the quality of the crop is not as good as it was in June.

PEARL SWINDLE STARTLES PARIS

Paris, Aug. 26.—(Correspondence of The Associated Press.)—How an American white pearl worth \$14,400 was treated with a chemical, given temporarily the rosy hue of an Oriental pearl and then sold for \$52,000 has been disclosed here. For doing this, Barboza, a pearl broker, and Varma a Hindoo, were fined and sentenced to imprisonment for faking. By use of chemicals they endeavored to increase the value of the pearls four-fold. This case clears up the mystery

which has existed in the Paris market for five years since a dealer in precious stones first learned that "manipulated pearls" were being sold here. Varma, who is a lapidary, claimed in court that he possessed a method of improving American pearls and that he had been promised a share in all the profits derived in treating the one which led to his detection, if it were sold for more than \$21,600. He was at work at it when it was seized by the police. The evidence showed that Varma has used on the pearl acetate of amyli and collodion. A pearl expert, Reinach, told the judge that Varma had given the pearl

the rosy tint of the Oriental pearl by glazing it with chemicals but that the glazing disappeared when the pearl was placed in alcohol. Varma was sentenced to six months in prison and to pay a fine of \$1,000, while Barboza was sentenced for three months and to pay a fine of \$100. In its judgment the court stated that sea pearls from the Orient are very lustrous and attain high prices while fresh water pearls, called American, are less fine, generally white and of lower value.
