Tailteann Games Are Revived

LONDON, August 16 - Ireland has just been seeing the revival of the magnificent spectacle of the ancient Tailteann Games. We owe the inauguration of the festival to the memory of a great Irish Queen, Queen Tailte was one of the most beautiful of the ancient Irish Sovereigns. She was a daughter of a Spanish King, and the beloved wife of Maghmor, the last ruler of the Firbolg Dynasty.

Tailte was greatly loved by her people. She was a staunch and active patron of the Arts, and music was the very pulse of her heart. Her admiration for the manly games of sport and skill was known the world over, and men came from the ends of the land to be present at such sports as were graced by the presence of "Tailte the Beautiful."

This splendid woman had one great sorrow - she was childless. Looking around for a successor to the Royal dignity of her famous House, she adopted a youth of Royal lineage, named Lugh (Lua). This youth she herself trained, and on her death she directed that Lugh be the future King of Eire. His name became a terror to the enemies of Eire. He reduced the invaders to serfs and became known as "Lugh-of-the-long-arm."

"When his State was firmly established, and peace had settled on the land, Lugh carried out a long-cherished plan. He issued a Royal Decree establishing as a national festival the magnificent games known then as Anochach Tailteann, or Tailte's Festival. This festival was to be held at midsummer, and in the year 632 B. C. the Royal Games started. Then, almost without a break, the games continued as a national festival up to the year 1169 of the Christian Era.

The first week in Lughnessa, the month of Lugh (August), the games began, and from the four shores of Eire the hosts assembled. There, around the tomb of Tailte, the people were wont to display all the splendid qualities of manhood in the contests set out for competition. Now when the festival was approaching, if any petty quarrels tended to keep the games back all the warrior-folk came to the conclusion that there was something more important than their private quarrels and at once a truce was called for the duration of the games of Tailte. The Royal Chiefs journeyed with their hosts to the Mount of Tailte and there forgot, in the joy of sport, all their petty jealousies and bickerings.

With them in their trains were the picked athletes - skilled horsemen, runners, jumpers, throwers of the spear, happy singers with their harps, and innumerable side shows, all to do honour to the great Tailte Queen and patron of sports. It must have been a sight to gladden the hearts of all true men. Together with the finest specimens of manhood the country could produce came the cream of Eire's lovely daughters. In this retinue of splendour passed in state by the Halls of Tara. There the King reviewed the people, and this first great day was known as the "Gathering Day," and it is not to be wondered at if at the end of the great festival other kinds of celebrations took place such as the giving in marriage, or the plighting of love vows.

All this is now revived in the Tailteann Games about ten miles from the famous Hill of Tara. Since the new United States Immigration Law went into effect, July 1, 1924, it has come to the attention of the American Consul at Charlottetown, that there is considerable difference of opinion as to the regulations regarding entry into the United States both for permanent residents and for temporary visitors.

In order to facilitate the entry of intending visitors, etc., into the United States the American Consulate wishes to make public the following regulations and rules. I. All persons proceeding to the United States to remain permanently, or for a longer period than six months, are required to appear personally at the American Consulate, Charlottetown, and submit two copies of their birth certificates, two small unmounted photographs and make application for a Non-quota Immigration Visa, for which there is a fee of \$10 United States currency. This fee is in addition to the head tax of \$8. Each member of a family, regardless of age must be in possession of this Visa if they intend to remain permanently in the United States. NOTE: (The possession of a Non-quota Immigration Visa will not entitle the person to whom it is issued to enter the United States if, upon arrival in the United States he is found to be inadmissible into the United States under the Immigration Laws.) II. Temporary visitors to the United States for business or pleasure are not required to secure any documents from the American Consulate, the only requirements being that they be able to satisfy the Immigration Officers at the border that they are Canadian citizens and that they only intend to remain in the United States temporarily. The Immigration Service has ruled that a temporary visit is any length of time in the United States under six months. It is suggested that persons going to the United States temporarily for business or pleasure carry a letter on their person from their employer or from some prominent citizen, stating that they are residents of this Province and that their interests and home ties are in this Province and that they do not intend to remain in the United States permanently. Temporary visitors should also be in possession of sufficient funds to support themselves while in the United States. III. The United States Immigration Service has ruled that all persons who have resided continuously in the United States since October 1, 1906, are considered to be legal residents of the United States and when returning from a temporary visit from Canada to the United States they should carry evidence as to their residence in the United States since October 1, 1906. If this evidence is unobtainable a sworn affidavit of two persons residing in the United States to such residence will be accepted by the Immigration Officers at the border. All persons who entered the United States subsequent to October 1, 1906, and who have not paid any head tax or who have not been legally entered are considered NOT to be legal residents of the United States under the Immigration Law. These persons must comply with the new regulations if they are going to the United States to remain permanently. IV. The United States Immigration Service has also ruled that persons who have previously paid their head tax and lived continuously in the United States since that time, are considered legal residents of the United States under the new Immigration Law. Persons who are re-entering the United States and returning from temporary visits to Canada through a port other than the one at which they paid their head tax, should write to the United States Immigration office at that port where they paid the head tax and request a "letter of verification of entry." Persons entering through the same port where they originally paid their head tax will only be required to state their name and date of their departure and that they also be in possession of the necessary documents, so that their cases may be handled without delay. United States Immigration Law

Since the new United States Immigration Law went into effect, July 1, 1924, it has come to the attention of the American Consul at Charlottetown, that there is considerable difference of opinion as to the regulations regarding entry into the United States both for permanent residents and for temporary visitors.

In order to facilitate the entry of intending visitors, etc., into the United States the American Consulate wishes to make public the following regulations and rules. I. All persons proceeding to the United States to remain permanently, or for a longer period than six months, are required to appear personally at the American Consulate, Charlottetown, and submit two copies of their birth certificates, two small unmounted photographs and make application for a Non-quota Immigration Visa, for which there is a fee of \$10 United States currency. This fee is in addition to the head tax of \$8. Each member of a family, regardless of age must be in possession of this Visa if they intend to remain permanently in the United States. NOTE: (The possession of a Non-quota Immigration Visa will not entitle the person to whom it is issued to enter the United States if, upon arrival in the United States he is found to be inadmissible into the United States under the Immigration Laws.)
