UNITED STATES AND SPAIN.

Arrival of Spanish Squadron at Porto Rico.

United States Squadron--Ready to Fight.

CONFLICT REGARDED AS ALMOST INEVITABLE.

President McKinley Preparing a Message.

WASHINGTON, April 2.—Spain has been given an extension of twenty-four hours to again consider the United States demands.

WASHINGTON, April 2.—The Spanish Flotilla has arrived at Porto Rico. The United States flying squadron was hastily joined by the Cincinnati and this squadron is held in readiness in Hampton Roads for sailing orders.

WASHINGTON, April 2.—Both branches of Congress adjourned until Monday. There is little doubt that the President and members of the Cabinet now regard a conflict with Spain as almost inevitable.

In his message to Congress which, in all probability will be sent in on Monday, it is understood that the President will review, at length, the record as it stands between this government and Spain, and will not insist upon further time in which to continue negotiations looking to a peaceful conclusion of the Cuban problem.

HAVANA, April 2.—The Spanish warships Viceaya and Almirante Quevedo left Havana at noon yesterday. It is believed that they have gone to join the torpedo flotilla at Porto Rico.

PARLIAMENT OF CANADA.

Increased Taxation—Half Cent a Pound on Newspapers.

SIR CHARLES TUPPER OPPOSES THE IMPOSITION.

Mr. Blair at Sixes and Sevens With Government Supporters.

OTTAWA, April 2.—The newspaper postage bill, introduced yesterday, proposes a half cent a pound on all newspapers.

Sir Charles Tupper opposed the measure. He said it was a scheme of the Government to keep the people from being informed about their deals. The Kettle River railway bill was brought up. This is the Corbin bill in which Hon. Mr. Blair takes such interest. The Government supporters obstructed the bill, so no advance was made with it.

two children, who were playing at a table. Calliard then entered the house and cut the throat of a little girl who was in the next room. Finally he blew out the brains of a paralytic bed-ridden woman seventy-one years of age. The murderer was arrested and confessed to committing the deed and a number of other crimes.

County Court Proceedings.

The County Court met to-day for delivery of judgements in suits reserved for consideration. Judge Alley read judgements in the following suits:

Wallace Wheatley vs. City of Charlotte town. This was a test action for the recovery of a License fee of \$15.00 paid to the city by the plaintiff as a milk vendor under a bye-law which the plaintiff claimed was ultra vires and illegal. The judgment was a very full exposition of the law involved in the suit and the Judge decided that the City was not liable to refund the money. Judgment for defendant. Arthur Peters Q. C. and A. Ernest Ings for plaintiff. The Recorder for the city.

Oliver Rattenbury vs. Wm Paquet and d Marshal Paquet. This was a suit tried in December term brought by plaintiff as endorsee of a promissory note for \$51.000 given by defendants in favor of Archibald Currie, Souris, and endorsed after it became due to plaintiff. Defendants claimed the right to offset or deduct from the note certain discounts due to them by Archibald Currie. The suit involved a nice legal question as to whether this claim could be pleaded in discharge of the note when endorsed to the plaintiff after it became due. The Judge held it could not be and gave judgment for the plaintiff. Plaintiff in person, W. A. O. Morson, Q. C. for defendants.

Trustees of school district No. 100, Milton vs. Edward McKinnon. An action for the recovery of school assessment brought against the defendant who is a non resident of the district. The defendant claimed that being a non resident of the district he was not liable for the current expenses of the school or for casual repairs to the building. The evidence showed that, the assessment was levied for shingling the roof and repairing the flue of the School house. These repairs were held by the Judge to be "casual repairs" and defendant was not liable for assessment in respect to them and gave judgment in his favor with costs.

There was a large docket this term embracing in all upwards of 250 suits. The court sat since Tuesday 22nd ult. and a number of these suits were tried, but we are unable to obtain an extended report of the business for today's issue.

A PLEA FOR THE BLIND.

SIR,—As previously announced in your columns a score or more of the officers and pupils of the school for the blind will leave Halifax for Charlottetown, on April 18th. It is our intention to hold several public meetings in your city in order to demonstrate the practicability of educating those who are deprived of sight. We believe that as the Provincial Government and Legislature makes statutory provision for the free education of those blessed with sight it should as a matter of justice make statutory provision for the education of those who are deprived of sight. Nova Scotia and New Brunswick have already recognized the education of the blind as part of their public educational systems and the Government and Legislature of Prince Edward Island are now being asked to recognize in the same way the claims of the blind youth of your province to a free education. We believe that public opinion in P. E. Island endorses the free education of those who are deprived of sight, and we hope that in the public meetings shortly to be held in Charlottetown in the interests of the blind this public opinion will find hearty and unreserved expression. I wish that every legislator and every intelligent person in P. E. Island could visit the school for the blind at Halifax, and see what is being done to prepare the pupils for fighting the battle of life, but as this cannot be, I trust that when a strong delegation from the school visits Charlottetown, every legislator and intelligent person will, by attending the public meetings have an opportunity of seeing for themselves what is being done to fit the pupils for life's battle. I promise all those who do attend a rich musical treat and a programme intensely interesting from start to finish.

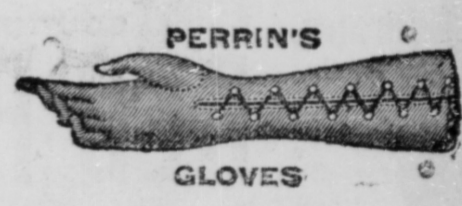
