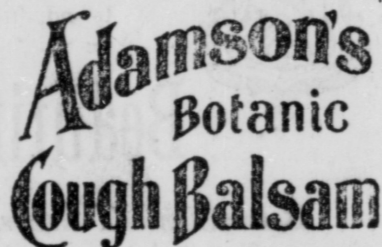

## THE BUTCHERY AT TIEN TSIN

### Details Being Received at Che-Foo.

### CHINESE GUNS AND FORTS SILENCED BY ARTILLERY.

### Recall of the British Minister at Peking Denied.

[SPECIAL TO THE EXAMINER.]

CHEE Foo, June 26.—The officers of the British first-class cruiser Terrible assert that discord exists between the Europeans and the Anglo-Americans, and say they believe that the Russians are planning to break the concert and take possession of Peking independently.

They assert that vice-Admiral Seymour's command lacked union,—the foreigners sulking because they were put under British leadership.

They bitterly denounce the general conduct of the Russians as uncivilized and barbarous, and charge that the slaughter of peaceful Chinamen at Taku has fused otherwise passive natives against the foreigners.

LONDON, June 27.—Horrible details of the butchery at Tien Tsin during the siege are being received at Che Foo.

An Express messenger says that the strength of the relief column is variously estimated.

The Central News says it was commanded by General Walter. Chinese guns and forts were silenced by the artillery and the allies then advanced on the town, the British and Americans being the first to enter.

Commander Wise, of the American warship Monocacy, who has been appointed commander at Taku, will see to the work of despatching trains with supplies to the front.

The gravest fears are still expressed as to the fate of Admiral Seymour's force. No official intelligence has yet been received here and reports as to the Admiral's position are somewhat mystifying.

Li Hung Chang has expressed his belief to a Canton correspondent of the Telegraph that America is the only power in which China can place her trust. The Americans, alone, he says, desire no accession of territory; and he therefore places himself unreservedly in their hands. The Viceroy has again been peremptorily ordered to go to Peking, and his enemies declare that they will murder him before he can reach there. It is his presence which restrains the revolutionary elements at Canton and his departure will let loose the black flags and red girdles.

The reported recall of the British minister at Peking is officially denied.

## BISHOP MACDONALD'S TOUR.

### Statue Blessed—Corner Stone Laid—Confirmation Administered.

On Saturday Bishop Macdonald blessed a statue of the Sacred Heart of Jesus at Palmer Road and confirmed a class of children; on Sunday he confirmed about 235 persons at Tignish and laid the corner stone of the new C. M. B. A. hall, after speaking in the highest praise of the institution and approving of it in the fullest terms. Sunday at 4 p. m. he made the pastoral visitation of St. Antoine de Bloombill where he was received with great pomp and ceremony and a very large concourse of people. He confirmed a class of 120 children, speaking earnestly to them in English after Dr. Monaghan's beautiful exhortation in French. He took occasion to warn the people against the loose morality of the day and strongly denounced those who carrying Catholic names and still adhering outwardly to the Church conspired to bring by their scandalous lives and sacrifice of honor and principle shame and opprobrium upon her. The church reproached such morals, and he only hoped that the children confirmed would lead lives of virtue to the end—true to God to Holy Church and to the Fatherland. His forcible words made a lasting impression on the vast congregation. Yesterday Bishop Macdonald administered confirmation at Brae.

## SUPREME COURT.

TUESDAY, June 26.

In the matter of the application of Mr. Arthur L. Sullivan for admission as a law student in the office of McLeod, Morson & McQuarrie, the Court made the usual order for examination.

The usual order was also made in the matter of the examination of Austin L. Fraser, preparatory to his being admitted an attorney of the court.

An order was also made for the examination of John A. McLellan, preparatory to his admission as a law student in the office of John A. Mathieson.

In two suits of James A. Leaman against William D. McKay, an absent debtor, judgment was given in favor of Mr. Leaman for \$4,721 and \$4,168.58 respectively. W. S. Stewart, Q. C., was counsel for Mr. Leaman.

In several cases against Herbert H. Acorn judgment was given in favor of the plaintiffs as follows: Imperial Oil Co., \$73; Pure Gold Manufacturing Company, \$47; F. W. G. Brock and another, \$206; W. M. P. Webster and another, \$51; Ames Holden Company, of Montreal, \$51. Mr. D. C. McLeod was counsel for the plaintiffs in the foregoing cases; J. A. Mathieson for defendant.

M. S. H. Harris Co. vs. Thos. F. Guard, judgment for plaintiff for \$123. D. C. McLeod for plaintiff; Morson, Q. C., for defendant.

Robt. D. Kirk vs. G. K. Ght, judgment for plaintiff for \$710. Morson, Q. C., for plaintiff; Bentley for defendant.

The Grand Jury brought in three true bills for house breaking and larceny against William Ellsworth, also a true bill for breaking jail. They also found a true bill, against William Walsh (Smiler) for burglary and an attempted rape. Walsh pleaded not guilty.

Ellsworth was this morning arraigned and pleaded "not guilty" to all the indictments against himself, excepting that of escaping from jail which he confessed. There are six jury cases on the docket which will be tried next week.

## THE BOERS ATTACK RUNDLE'S TRANSPORT

### But are Repulsed by The British

### FIFTY WAGONS CAPTURED BY THE ROERS

### German Corps With the Boers Suffers Severely.

BERLIN, June 27.—The Berliner Tageblatt publishes correspondence from Vrehtkop, dated May 12, regarding engagements around Zund River in which a German corps with the forces is described as having suffered terribly. The list of killed and wounded is given.

LONDON, June 27.—The War Office has received the following from Lord Roberts: "PRETORIA Residence, June 26—Sir Charles Warren reports that the rebellion in Cape Colony, north of Orange River, is now over. The last formidable body under commandant Devillers surrendered on the 20th inst, consisting of 260 rifles, 220 men, 280 horses with wagons, 260 rifles, 100,000 rounds of ammunition.

"General Baden-Powell reports that pacification is going on satisfactorily in the Reutberg district.

"The Boers sharply attacked General Rundle's transport near Senekal, June 23, but were repulsed.

"An official report of the capture of 50 wagons escorted by the Highlanders between Rhenoster and Heilburn, June 4, was only received yesterday. Lord Roberts reports that the convoy was surrounded, and sent messengers to the nearest point asking for assistance. But the reinforcements were unable to reach the convoy and 150 Highlanders in reply to a flag of truce from General Christian Dewet, surrendered during the morning of June 24."
