Conference of N. B. and P. E.

Island at St. Stephen.

(From our own Correspondent.)
JULY 3, 1883.

CENTENNIAL MEETING.

President in the Chair. On the platform
were Z. Chipman, Esq.; Rev. F. Small-
wood, Dr. Rice and Rev. D. D. Currie.
Mr. Smallwood led in prayer. Rev. H.
Daniel gave an account of the state of the
country, with special reference to Metho-
dism, fifty years ago. He referred to St.
Stephen, St. Andrew's, and other places.
His speech was very interesting. Rev. E.
Evans read an old document, dated 1792,
showing that Rev. Duncan McColl was then
the authorized minister of St. Stephen.
Rev. Dr. Rice gave a very able speech.
He spoke of his call to preach, and of his
entering the work forty-six years ago. He
called attention to some distinguishing
features of our Church then. Rev. D. D.
Currie followed in a brief but humorous
speech. After a collection the President
pronounced the Benediction.

There was a short evening session when
the Secretaries read some tables of statistics.
After a short discussion upon them the
Conference adjourned.

On motion of Dr. Stewart a resolution
respecting District Scholarships on behalf
of Mount Allison College, was ordered to
be inserted in the minutes.

Rev. J. C. Berrie was appointed corres-
ponding member of the Central Sabbath
School Board.

Revs. Dr. Sprague, S. R. Ackman, and
W. R. Pepper, received permission to visit
England. Rev. D. D. Currie read the
report of the Children's Fund Committee.
Provision is to be made for 1904. After
short conversation the report passed.

A letter of sympathy was ordered to be
sent to Rev. Jeremiah V. Jost who was
detained at home by reason of sickness.

A letter of condolence was sent to the
widow of the Rev. H. McKeown.

The Centennial Fund Committee recom-
mended that Rev. C. W. Dutcher be set
apart for one year as Agent. Mr. Dutcher
respectfully declined the appointment.

A conversation took place on the question,
What further measures can be adopted to
help our work? in which Revs. H. Daniel,
Dr. Pickard, F. Smallwood, and J. C.
Berrie took part.

Rev. D. D. Currie was appointed for one
year as agent of the Centennial Fund.

Thanks were presented to J. J. Anslow,
Esq., for the faithful reports he had for-
warded to the "Globe," and to the publish-
ers of the "Globe," for a daily supply of pa-
pers. Thanks were also passed to the
"Telegraph," "Sun" and "St. Croix
Courier," for their reports, and to the
managers of railroads and steamers that
had given special rates to delegates.

Rev. R. Duncan was appointed Confer-
ence Representative to the Central Mis-
sionary Board. Rev. J. Read was appoint-
ed Ministerial Representative and J. J.
Weddall, Esq., Lay Representative on the
Supernumerary Fund Committee.

Rev. H. Daniel was elected a member of
the Transfer Committee. Conference then
had the appointments of ministers read, and
proceeded to the appointment of the
Chairmen, with the following result:—

St. John District—Rev. J. Read, Chair-
man; Rev. Job Shenton, Financial Secre-
tary.

Fredericton—Rev. E. Evans, Chairman;
Rev. C. W. Hamilton, Financial Secretary.

Miramichi—Rev. D. Chapman, Chair-
man; Rev. J. N. Parker, Financial Secre-
tary.

Sackville—Rev. J. S. Phinney, Chair-
man; Rev. J. J. Deinstadt, Financial
Secretary.

St. Stephen—Rev. R. Duncan, Chair-
man; Rev. C. W. Dutcher, Financial
Secretary.

P. E. Island—The President, Chairman;
Rev. H. P. Cowperthwaite, A. M., Finan-
cial Secretary.

Next Conference is to be held in the
Centenary Church, St. John, by the unani-
mous request of the Quarterly Board.

At 4 p. m., the Secretary commenced
reading the minutes, and about 5 p. m. the
President and Secretary signed them in
the presence of about thirty-five preachers,
and the Conference adjourned. Prayer
was offered by Rev. J. R. Borden of the
Nova Scotia Conference.

In the evening, a Temperance Meeting
was held, Rev. J. C. Berrie in the Chair.
The speakers were Revs. C. Comben, S. R.
Ackman, and Levi S. Johnson. The con-
gregation was not large. This ended the
public services of the Conference.

The Law of Newspapers.

It is an unwritten law well understood
in journalism that no editor is under the
slightest obligation to give a reason for his
acceptance or non-acceptance of a manu-
script. He is not called upon to write a
private critique on the article or the author
of it. His acceptance or rejection is an
absolute and unquestionable fact. Among
amateur writers this does not appear to be
understood. All sub-editors and report-
ers understand that it is an unjustifiable im-
pertinence to ask the managing editor his
reason for publishing or not publishing any
matter submitted to his judgment. Out-
side writers and aspiring amateurs rarely
seem to comprehend this truth, and their
transgressions are largely from ignorance
rather than intention. The nature of
editorial work requires absolute power of
decision, in order to preserve the unities of
the journal the editor conducts.—Boston
Traveller.

In a Quandary.

A lie will out. Some time ago the Re-
form Leader of the Standard Elevator in
Manitoba denied that he was the author of
a grossly unjust circular reflecting upon the
Manitoba Government which was issued
just before the elections one day last week.
However, Mr. Norquay in the course of a
decision in the House incidentally said that
he had an idea that some body in the
Opposition Benches had written the circu-
lar. At this there was cry of "Name
name!" Mr. Norquay paused for a few
moments and then said:—"I have very
good reason for supposing that circular was
written by Mr. Greenway, the member for
Mountain."

"Mr. Greenway leaned back in his chair
and said:—"I never saw the circular—I told
you that before." Shortly afterwards Mr.
Brown, the Minister of Public Works, rose
to speak. He said there was a general
impression that Mr. Greenway's denial of
the authorship of the circular was in some
way qualified, and he would like to know
positively whether the hon. gentleman still
persisted in disowning the circular. At this,
Mr. Greenway said:—

"I said the other day, and I am prepared to
still vow, that I know nothing of the circular,
and never saw it."

"Mr. Brown drew out a sheet of paper, held
it out at arms' length, and said:—"Is that your
handwriting? If you deny it I am prepared
to prove the handwriting by another document
over your own signature, containing the terms
of your agreement to go over to the Reform
party. There are members of the House who
who are prepared to swear to the handwriting."

A sensation followed!

Well Bred Trotting Horses.

The term "well bred" is often used in re-
ference to horses by those having no clear
idea of its significance. In general it in-
dicates those relations to horses that have
shown great speed in public whether run-
ning or trotting bred. Of the latter, only
three families have shown first-class speed
and campaigning quality, viz., the Mam-
brinos, Hambletonians and Clays. The
descendants of Vermont's Black Hawk pro-
duce speed with considerable uniformity,
but lack the constitutional capacity to
"campaign," a quality invaluable in the
composition of the turf horse. Unquestion-
ably the most successful cross yet made is
the union of Mambrino and Hambletonian.
The present season has demonstrated more
than ever the value of this. The most
notable horses which have thus far
appeared are Majoieca, record 2:17
in his first race and Phallos, 2:14
in the fifth heat of his first race.
The blood of both is identical, being Hamble-
tonians sired and Mambrino dams. In the
case of Phallos there is a double infusion
of the Mambrino, his granddam being
also of that blood. Other great campaign-
ers bred in the same way are Santa Claus,
Edwin Thorne and Piedmont, with one
Hambletonian and two crosses of Mam-
brino blood. Trinkett is another of similar
breeding, her sire being Princeps, son of
Woodford Mambrino. Another horse
whose blood was exceedingly prominent on
the turf last season was Mambrino Patchen,
whose daughters produced the great mares
Clora and Rosa Wilkes, the latter winning
in a single season 24 in a total of 26 races,
and invariably in the best company.

P. T. Barnum on Intemperance.

Churches, Sabbath schools, and religious
influences ought to do much towards reduc-
ing the evils of drunkenness; but they
should appeal to the common sense of their
hearers, and give them the present and
immediate future's positive, unerring and
undeniable results, right here in this
life, to those who so unwisely break
the laws of nature. Appeals made by re-
ligious sectarians, and threats of dreadful
consequences in the future life, instead of
right here and now, and all talks about the
pleasures of sin and joys of inebriety, which
must be paid for in the future world, as
well as all appeals of a sanctimonious char-
acter, and assertions that nothing can re-
form drunkards except the Holy Spirit,
mysteriously exercised through some
church organization, I believe, deter many
intemperately inclined men from seeking
to change their habits, when they would
readily listen to and be controlled by honest,
earnest statements of facts, based upon the
experiences and observations of every-day
life.

and a widow—both of Aberdeen. The
widow, who called upon the minister, seem-
ed desirous of relieving her mind of some-
thing which oppressed her, at which the
reverend gentleman, wishing to hurry mat-

tell me what it is that troubles you."
"Well, sir, I'm this kind of gettin' married
again."

"Oh, that is it! Let me see, that
is pretty frequent—surely! How many
husbands have you had?" "Well, sir,"
she replied in a toneless of sorrow than
of bitterness, "this is the fourth; I'm sure
there's nae wumman been sae tormented
wi' a set o' deasin' men!"
