DIRECTIONS.—Artificial Slate: Mix the powder with pure Boiled Linsed Oil and a little Spirits of Turpentine, to the consistency of very thick Paint, and applying with a common Brush, being careful to keep the mixture well stirred while putting it on. One pound will cover ten square feet with two coats.
