To the Editor of the Examiner:

SIR,—The intelligent electors of Georgetown and Royalty feel it their duty to re-elect the Hon. D. Intercepted Letter.

IN WHICH SUNDRY LITTLE DODGES ARE EXPOSED.

CHARLOTTETOWN, March 29, 1879.

MY DEAR O'CALLIGAN,—I regret that you had to leave Summerside after you were put in nomination, as I think your chances would be better there than in the Bedeque district. I fear that you have been too outspoken about the Greeks, and that you are doing the Protestant Party harm. The only chance there is for any of us getting elected, is to humbug the Greeks. The policy I have adopted in my canvass, and it is one you will do well to consider, is to blamey them in public meetings. But in canvassing from house to house I ask the Protestants if they intend to vote for the Pope at this election.
