LAND ASSESSMENT.

Treasurer's Office, Charlottetown,
Prince Edward Island, 30th May, 1843.

IN pursuance of the Act of the General Assembly of this Island, made and passed in the Seventh year of the Reign of His late Majesty King William the Fourth, intitled *An Act for levying an Assessment on all Lands in this Island*—I do hereby publicly notify the Owners or Occupiers of Land within this Island, for which the Annual Assessment charged thereon by the said recited Act, of Four Shillings, lawful money of this Island, for every Hundred Acres of wilderness or unimproved Lands contained in the several Townships, and the several Islands belonging thereto, and the sum of Two Shillings for every Hundred acres of cultivated or improved Lands in the said several Townships and Islands as aforesaid; and the sum of Four Shillings for each and every uncultivated or unimproved Town Lot, Pasture Lot, Common Lot and Water Lot, granted in the Town and Royalty of Charlottetown; and the sum of Two Shillings for each and every cultivated or improved Town, Pasture, Common, and Water Lot as aforesaid; and the sum of Two Shillings and eightpence for each and every Town Lot, Pasture Lot and Water Lot, granted in the Towns and Royalities of Georgetown and Princetown; and the sum of One shilling and fourpence for each and every cultivated or improved Town, Pasture and Water Lot, granted in the said last mentioned Towns and Royalities, and so in proportion for a less quantity; and the sum of One penny per acre on each and every acre of cultivated or improved Land in the Royalty of Georgetown, called reserved Lands; and the sum of Two-pence per acre on each and every acre of such Lands as may be deemed uncultivated or unimproved Lands, is payable, that unless the Assessment for the current year be paid into my hands, or the hands of my Deputies, on or before the Twenty-first of December, 1843, I shall, on the last day of the next Hilary Term, at Charlottetown, make Proclamation of all such Lands as shall then be in arrear for non-payment of the sums charged thereon, agreeably to the directions of the said Act.

TO THE EDITOR OF THE COLONIAL HERALD.

Sir; The political character of your correspondent, CURTIS, appears in such bold relief throughout his first letter, that I feel I need not hasten to pourtray it as a means of fairly estimating the opinions he seeks to inculcate upon the minds of his readers; yet I will endeavour to do so before I conclude with him. Did I believe that the aim of this man was even chiefly to distinguish between good and evil; to unstrip the latter of the disguise which throughout the world, it is too often found to wear; to point to where, in any shape, it existed in the Colony, and then to suggest some rational remedy for its removal, I would not, in such case—although supposing him to be in error—obtrude myself on the public, but would leave to competent hands the less easy task of correcting him. CURTIS, however, I consider to be pursuing another, and a widely different, object—"Evil be thou my good."

The Leveller, whatever his acquirements may be, is one on whom the world but rarely bestows either its wealth or its respect; and that conduct and feeling which CURTIS falsely attributes to the superior orders of society in this community, and that patronage which—with equal untruth—he ascribes to the influence of wealth, are sentiments such as I surely need not point out to that reader who could peruse his letter throughout, without pronouncing Mr. CURTIS to be the possessor of precious little, if any, of either one or other of those desirable, and to him, no doubt, enviable properties.

No, Sir, if CURTIS were to revive agitation and strengthen discontent—even beyond his fondest hopes—I premise that, however varied might be their consequences, he would have but little to lose or suffer. Like the loathsome insect, however, which derives its choicest sustenance from certain matter and bodies when in a state of fermentation, there are to be found men of that character who have something sufficiently valued to derive from the prevalence or effects of excitement among the many. In this country, vindictiveness, or the gratification of malice towards land proprietors, is a motive sufficiently powerful to some individuals, whose loose and immoral characters have caused their proffered services, as sub-land-agents, sub-land-surveyors, or even salaried sub-stewards, to be rejected.

The temptations, too, which present themselves in the ideas of a cushioned chair, comfortable apartments for the winter months, and Thirty Pounds, cash, per year, have a wonderful effect in drawing forth the latent sparks of patriotism, and kindling, in the breasts of some, the genial warmth which inspires them to advocate against the oppression of the tenantry. I may, perhaps, be unjustly underrating the feelings of our nature; but my observations are made, conceiving that among those who dip their oar in the troubled waters between landlord and tenant, there may be a solitary being whose labours spring from a different incentive than that which characterizes "the christian philosopher—the man of honest and humane reflection."

The credulity of the peasantry of this Island, and the facility with which they have been imposed upon by the agitators who have so long played upon their minds, is not so very astonishing as we hear at times remarked upon. The labour of a new settler, who begins the world as an agriculturist, with a young family and without means, is certainly trying; and although by no means greater than that of one under the same circumstances in any part of Great Britain, yet the disadvantages of a severe climate, and the want of a ready money market, are greatly discouraging to his efforts. While enduring these hardships, it requires nothing beyond the low cunning of the demagogue to persuade him that the difficulty of paying his rent is entirely owing to its being unreasonably high; that, as the proprietor's ancestors or predecessors—some seventy or eighty years ago—purchased the whole township at a very low rate, to demand such a rent now—so disproportioned to the value of the fee simple then—is unlawful; and that, by a uniform resistance of payment, it must sooner or later inevitably be reduced. It is by this means, together with the circumstance of the press of this Island having, for a period of years, hitherto, by its too frequent subserviency to popular clamour, giving publicity to the ebullitions of the agitators, and of these being considered intrinsically too ridiculous and contemptible to be answered, that the people have—unfortunately for themselves—become so deeply prejudiced against their landlords. Happily, however, during the last two years, an essential change has manifested itself among the tenantry of the Island. The abundant returns of the crops; the rapid increase of settlement; the greatly enhanced value of lands of all kinds throughout the Colony; but, above all, the decided sentiments of Her Majesty's Government on the land-tenure question, as carried out by the frank and totally independent conduct of our present Lieutenant Governor, have had wonderful effects in opening the eyes of the people to the delusions that have so long been practised upon them.

To none more plainly does this appear than the remaining agitators themselves. Their renewed and new-fangled devices to maintain their "occupation," serves but to shew how sensibly they feel themselves retrograding to their original obscurity, and also the dread of the contempt which they have earned for themselves. Like a set of hunted rats, too, on the floor of a closed apartment, the smaller their number is reduced, the more desperate becomes their fight and efforts for existence. The ragings and fierceness of these gentry are certainly superlatively ridiculous. For the entertainment of the mind, it is really worth while watching the windings of the more wily of them. "Discontent and dissatisfaction (think they) are the subjects of our own creation—the fruits of our perseverance and industry; the success of our fabrications, our imaginary evils, and grossly exaggerated facts, in relation to the land tenures. We are responsible for both, and have a right to apply them as we please;" and, constituting themselves the organs of the people's feelings, like the pipeman of a fire engine, they endeavour to direct the passions and discontent of the people, as the stream, against any object that best suits their purposes, and in the hopes of saving their credit. Thus friend CURTIS assails the construction of the Councils. After propounding that wealth and superiority are disqualifications to such official appointments, he follows this up by unflinchingly asserting that "our Councils are filled with money and land and commercial monopolists." In his opinion, a man who owns two or three thousand pounds' worth of land should, on that account alone, be ineligible for a seat in the Council! Whether absolute folly or errant effrontery most predominate with him here, it is difficult to say. And then, mark his further statement. After proving so profoundly "this rotten state of Denmark," he continues—"With a Legislative Council containing three land proprietors—three agents for absent land claimants," &c. How unconstitutional! how dangerous! how unprecedented!

But where are the three proprietors, veracious CURTIS? With the exception of the Hon. Don. Macdonald, what other member of the Legislative Council, by name, owns a quarter of a Township of land in this Island, or any quantity near that amount? Yet CURTIS stops not here. The old song of "Family Compact," must be kept in view. "Our Executive Council," he says, "is composed of persons knit together in every variety of connection by the ties of blood and marriage."
