

political characters in Parliament, with whom his impeachment originated, he was allowed a copy of it, and time was given him to prepare his defence. To shew not only that Warren Hastings had been furnished with a copy of the charges preferred against him by the House of Commons, and allowed him ample time to prepare his answers and defence, but also that such a course had not been pursued with respect to him, as of a special favour, but as a privilege which every British Subject, in similar circumstances, had a right to claim; he would read two short passages from Lord Campbell's Lives of the Lord Chancellors; the first from the Lord Chancellor Thurlow's address to Warren Hastings when put on his trial, and the second from his (the Lord Chancellor's) observations, at the close of Mr. Burke's opening oration, with reference to the latitude and licence which ought to be allowed to the accused in making his defence. The hon. and learned member then read the first passage as follows: "Time has been allowed you for preparation, proportioned to the intricacies in which the transactions are involved, and to the remote distances whence your documents may have been searched and required. You will still be allowed bail, for the better forwarding your defence, and whatever you can require will still be yours, of time, witnesses and all things else you may hold necessary. This is not granted to you as any indulgence, it is entirely your due; it is the privilege which every British Subject has a right to claim, and which may be claimed by every one who is brought before this high tribunal." And then the second: "But in proportion as I am ready to punish Mr. Hastings with severity when lawfully convicted, I must see that he has a full and fair opportunity of vindicating his innocence. This he can only have by hearing all that is to be said or proved against him under all the charges, before he is called upon for his defence. With respect to the usage of Parliament, of which we have been told so much, as contradistinguished from the common law, I utterly disclaim all knowledge of it. It has no existence. In times of barbarism, indeed, when to impeach a man was to ruin him by the strong hand of power, the usage of Parliament was quoted in order to justify the most arbitrary proceedings. In these enlightened days, I hope that no man will be tried but by the law of the land, which is admirably calculated to protect innocence and to punish guilt." The hon. and learned member then continued: "The same rules of law and the same privileges were applicable to the enquiry then before the House, and to refuse to extend them to the investigation, by furnishing the late Colonial Secretary with a copy of the Report, and allowing him a sufficient time to reply to it, would be a gross abuse of power, to exclude him from those legal and constitutional privileges, to which, even the vilest and most reprobate criminals were admitted. Should the majority in the House proceed in the matter, as it appeared to be their determination to do, the Journal in which their proceedings would be entered, would afford a record of one of the most flagrant acts of injustice that had ever been perpetrated, under the colour of parliamentary enquiry in any Colony of Great Britain. It would exhibit a record of a parliamentary majority having proceeded, upon a report of three of their own body, to pronounce judgment against an individual, to whom they had denied an opportunity of defence, and, with respect to whom, they were not only his sole accusers, but moreover, at the same time, stood towards him in the relation of judge and jury. To these observations, tantamount to his protest against the course about to be pursued by the majority with respect to the Report, he would confine himself; but he would (as he easily might have done), have said much more against so arbitrary a proceeding, had he not been restrained by his sense of the peculiar relation in which he stood to the late Colonial Secretary.
