The lecture was listened to throughout with deep interest and attention, and a very animated discussion followed, in which some doctrines of phrenology, which had been advanced, were impugned and contradicted, upon anatomical principles. From the novelty of the subject in this community, it was proposed that an additional evening should be devoted to its discussion, as the lateness of the hour prevented its being so fully canvassed as the audience seemed to desire. The meeting adjourned, and arrangements have since been made, (the Rev. Mr. Knox consenting) for the continuation of the subject on next Wednesday evening, which will, positively, be the last night for the season.

The President will close the course, as formerly announced. The Chair will be taken at 8 o'clock, precisely, and the doors will be closed at a quarter past eight.

Sailed from Plymouth, April 2—the William, Larmour, for P. E. Island. —from Bideford, April 10—Spec, Marshall, for ditto. —from Liverpool, April 17—Barque Northumberland, for do. LOSS OF THE BARQUE STRADONA.—Capt. Dyer, of the Am. brig, Franklin, from Newfoundland, which arrived here on Tuesday last, reports the loss of the barque Stradona, from Liverpool, for Montreal, with a valuable cargo of tea, dry goods, &c. She went down among the icebergs off Cape Ray, S. W. point of Newfoundland, at midnight, 24th April. The Captain (Wm. Robinson) and crew, 17 in all, succeeded in reaching Cape Ray in their boats, whence they were taken on the 28th by the brig Franklin; and brought to Pictou.—Mechanic & Farmer, May 5.

The Ben, Forrest, from Sydney, reports having piloted the schr. Messenger (Sealer), of Harbour Grace, N. F., with 2,800 seals on board, into Malabar Bay.

DIED. At Montreal, suddenly, aged 67 years, Joseph Bouchette, Esq. Surveyor General of Lower Canada. Colonel Bouchette was a native of Quebec, son of Capt. Bouhette, by whose assistance, in 1775, Sir Guy Carlton, then Governor and Commander in Chief of the Province, effected his escape to Quebec, when the remainder of the British forces, retiring from Montreal, surrendered at Sorel. Col. Bouchette succeeded Mr. Collins, who was the second Surveyor General of Canada under the British Government, Major Holland having been the first. On the 23rd March, aged 87, John Hill, Esq., of Exmouth, Devon, formerly of this Island.

TO THE EDITOR OF THE COLONIAL HERALD. "Audi alteram partem." Wonders will never cease!!!

SO, Mr. Editor, the famous Wood Island affair, after all the noise and clamour that have been made about it—after the honourable Mr. Holl made it a conscientious point of duty to report it at head quarters—after Mr. George R. Young made it a subject of serious meditation for, and of sufficient magnitude to disturb, the midnight slumbers of the man that presided over the destinies of the vast Colonies of Great Britain—after "O.P.Q." brought it forward as a heinous charge against the electors of Mr. Charles Young—after Mr. Holl again was at the pains of giving a full and faithful narrative of it to the public—after Messrs. Stewart and Grossard made a full display of their polemic powers, in their valorous attack upon my humble self, for my daring presumption in calling in question its great importance, and in venturing to say a single word in behalf of a people among whom I have lived for very nearly the last twenty years, and whom I knew to be vilified and abused, far, far above what any fault which they had committed deserved—turns out, after all, to be but a new exemplification of the mountain in labour, for it is proven beyond a doubt that there was not as much as a disrespectful word addressed to the gentlemen principally concerned in this affair, from the beginning; and Mr. Douse himself, the able apologist and sturdy defender of the mighty fraternity to which I have alluded, does not advance a single instance in which the poor Wood Islanders have been guilty of a breach of the public peace, or of the slightest resistance to the established laws of the land; nay, notwithstanding his eloquent gasconading, that none can be found amongst them that ever refused to pay his rent, if he only had the means (as will be abundantly proved in the sequel). Only think of this, my Lord Glenelg! And if there be a tenant in the Wood Islands that ever did actually refuse to pay his rent, the onus probandi must certainly rest with Mr. Douse himself.

With respect to our travellers, whatever may have been the amount of the offence given them, by the flourishes of one or two foolish individuals, since the party had happily come off scathless, without damage sustained in wind or limb, (with the exception, perhaps, of a slight temporary fright or so, to which I have heard it said that even the noblest spirits are sometimes subject, on their first encountering an enemy in the open field,) would it not have been fully as gallantly done to the fair heroine of the broken pitchfork, and fully as generously done to the brave firer of the solitary shot, at 220 yards distance, and in an opposite direction, (not to speak of the rest, who are chargeable with no offence at all,) if the gentlemen had treated the whole matter as a mere piece of frolic or adventure, undeserving of any further notice, instead of having made it a subject of grave representation to the authorities of the country. It here, I suspect, that the shoe pinches. Thou memorable broken pitch-fork! and thou no less memorable shot! sorry I find that it has not fallen to an abler historiographer to record your praises in terms more equal to your merits; and sorry I find that your old friend PLAIN COMMON SENSE would of again lend the aid of his plastic hand to do you justice. I beg to express my unfeigned respect for Mr. Jenkins, whether he be the author of the elegant stanzas which have appeared in the Gazette or not, and to thank him for the calm

and gentlemanly tone of his communication. I wish I could say as much of some of the other members of the expedition.

"Sir L. he was a gallant knight; But for the other two, Sing cock-a-doodle, cock-a-doodle, cock-a-doodle-doo!" Of Mr. Douse's effusions (the greater part of which, to do him justice, I really believe to be his own,) I mean to take but a very transient notice. His intimate acquaintance with the "glorious Will," and with the "mimtable Jack," (whom he accuses me so much of making the companions of my studies,) I must confess, surprises me a little, for he seems to have the faculty of calling up his men in buckram, upon the occasion, with the same ease as the valiant Knight himself. This, perhaps, may be one of the advantages of having a "familiar" at one's service. Of this gentleman I would only remark, that I have not much taste for returning railing for railing, or abuse for abuse; but I must say, that whatever degree of excitement prevailed in this section of the country at the time the occurrence took place, which formed the groundwork of this discussion, that it was much more owing to his own indiscretion in publishing reports which he could not substantiate, than to any influence produced by the Governor's letter; and nearly as much as to that produced by the letter of the Apostle of Eschate himself. And I leave your readers to judge, from facts attested by others, to which of us both do those gentlemanly epithets, of which he is so lavish, the more properly apply. Compared before me—Peter Emery, Esq. one of Her Majesty's Justices of the Peace for Queen's County—Malcolm Shaw, tenant on the front settlement of the Wood Islands, who maketh oath and saith—That he never refused, at any time, to his knowledge, to William Douse, Esq. to pay any more rent—although he frequently complained of it as a great hardship and injustice, to be obliged to pay rent for the Fishery Reserve on his farm, as he considered himself liable, continually, to be deprived of this part of his complement of land—that the Fishery Reserve on his farm comprehends 26 acres of the best part of his clearance—that as every one knows he is yearly much troubled by fishermen, whose encroachments it is impossible for him to resist—that there is not a farm on the Wood Islands shore that is not more or less troubled by fishermen, although none, he believes, to the same extent as his own—that were the Fishery Reserve thrown open to the public, there is scarcely a tenant or freeholder on the shore settlement of the Wood Islands that would not justly cause to fear that he would be deprived of the front of his farm, as, even where the bank is highest, quantities of fish are carried up every season, not only by the inhabitants themselves, but by strangers from a distance, and dried and secured on the top; and as to the beach of the Islands, the place alluded to by Mr. Douse, the sand is so loose on it and so ready to be driven by the wind, that it is totally unfit for the drying and curing of fish—That any objections which he offered at any time for the payment of his rent, was on the ground of the Fishery Reserves alone, and that all that he wanted, or does still want, is to have this question settled, and to be freed from future annoyance or disturbance in his possession. That in regard to any degree of excitement or agitation, which prevailed in the winter of 1838, this deponent never acknowledged himself, to Mr. Douse, to have been deluded or deceived by any person or persons, and that he is not aware of any other of his neighbours having done so. - 1. That a fund shall be raised, to defray the expenses of the undertaking. 2. That every person subscribing the sum of Five Pounds, shall be entitled to select from Emigrants consigned to the Society, two Servants, male or female, of the following description, viz: domestic servants, as grooms, gardeners, &c., or one farming bailiff or cook. 3. That every person, on paying Two Pounds Ten Shillings, shall be entitled, in the same manner, to one servant; but in the cases of farming bailiff or cook, Five Pounds must be paid. 4. Three farming labourers will be considered as two domestic servants, and paid for accordingly. 5. Two male servants or labourers, under 18 years of age, and two women (not cooks), to be considered as one adult man servant. 6. An Agent will be appointed in London, with several correspondents in the country, to transact the business of the Society; in respect to forwarding Emigrants, and affording them necessary information. 7. This Agent shall be authorised to advance, in part payment of passage, £2 for every adult, and £1 for every person under 14 years of age, and of age to be employed. 8. The Society will forward to their Agents instructions applicable to every class of Emigrants, whether designing to take Land, and whether possessed of small or larger capital; likewise, the necessary information for artisans, and all others; and with any parties the Society will be happy to correspond; and it will be their particular aim to contract for and facilitate the passage of all descriptions. 9. A particular Register will be kept by the Agents respecting the wants of the Colony, in all particulars as to Emigrants; but no pecuniary aid will be given by the Society to any other classes of persons than those before enumerated. Openings for particular occupations will be particularised. Edward C. Haythorne, and William Swabey, Esqrs., will afford any further information and receive subscriptions. The number of subscribers is already considerable.
