DEBATE ON THE ADDRESS.

So far the debate on the address has been decidedly favorable to the Opposition. The Government's record is indefensible at many points; and the opposition led by Sir Charles Tupper, is full of vigor. An advantage in the fight possessed by the Conservatives, lies in the strong contrast between the Liberals pre-election promises and the post-election performance of their administration. During all the years they were in opposition the Liberals posed as the pure, the economical, the able, par excellence; and they imposed upon the country the belief that when they gained power, they would stand out as decidedly superior, in every respect, to the Government of Sir John Macdonald, Sir John Thompson, and Sir Bowell Mackenzie. 'But what a fall was there my countrymen'—instead of purity there is jobbery in almost every movement of our Liberal administration, from the purchase of a cargo of coal to the appointment of a governor. Instead of economy there has been largely increased expenditures, instead of ability to fulfil their pledges and carry out their designs there has been failure along the line. This has been made evident by the debate. Not to speak of the East Line Service, or the American negotiation, or the 'Biblicite' humbug, or Free Trade, take the matter of the British preference ventilated by the Hon. Clarke Wallace. Mr. Wallace was able to show that the preference was merely a pretence. He pointed out the Liberals first put up the duties on large lines of British goods in such a way that the 25 per cent. preference merely brought the tariff to something like the old basis as regards Britain, and that duties on large lines of goods which we buy in the United States were considerably reduced—resulting in an increased American sale to Canada to the amount of \$30,000,000, while British sale to Canada have scarcely increased at all. An answer to this statement has been demanded; but it has not been given. The Government have, indeed, discreetly adopted the prudent policy of silence in respect to many of the questions raised by the opposition; and some of the more candid of their speakers have frankly admitted that the Conservatives were right about Protection and other things. The advantage of the debate, thus, lies with the Conservatives.

THE SPECTATOR'S CATECHISM.

In view of Sir Wilfrid Laurier's boast and the Toronto Globe's declaration that the government have satisfactorily settled many great questions, the Hamilton Spectator asks,—

How about the fishery arrangements which the Yankees claim are oppressive, and which Sir Wilfrid Laurier declared to be an "outrage." Have they been "satisfactorily settled?"

Is the new franchise act a settlement that is "satisfactory?"

Has the great American grievance about seal catching been satisfactorily settled?"

Is the alien labor business "satisfactorily settled?"

Is the Mackenzie-Mann railway business "satisfactorily settled?" Looked at from the Globe's point of view?

Is the fate of the Ontario vs "old ladies" of the Senate "satisfactorily settled" from the same point of view?

And how about the Deauville railway deal? Does the Globe think that was "satisfactorily settled?"

Is Sir Richard Cartwright's proposal to wipe out every vestige of protection "satisfactorily settled?"

Is Sir Wilfrid Laurier's promise to give Canada free trade as it is in England "satisfactorily" done?

Is the fool proposition to follow American war vessels the use of Canadian canals "satisfactorily settled?"

Is the Manitoba school question settled in a manner satisfactory to the Manitoba bishop or to the (Protestants of the Province?)

Is expenditure of public money in an economical manner an accomplished and satisfactory fact?

Is the Alaska boundary dispute "satisfactorily settled?"

Is the question of the bonding privilege "satisfactorily settled?"

Is the coal oil duty business "satisfactorily settled?"

Is the farmer of the North west satisfied that the promise of free agricultural implements is satisfactorily carried out?

Is the Pacific cable matter "satisfactorily settled?"

Is the "preferential" duty which increases British imports 1 per cent, and American imports 20 per cent a satisfactory settlement? Is it a settlement at all?

Is the question of export duty on pine logs "satisfactorily settled?"

Is the matter of an export duty on pulp and pulp wood "satisfactorily settled?"

Is the question of an export duty on nickel ore and matter "satisfactorily settled?"

Is the fast Atlantic steamer question "satisfactorily settled?"

Is the question of reciprocity with the United States "satisfactorily settled?"

The answer to each of these questions is No—an emphatic No.

Perhaps the Globe will be good enough to enumerate some of the important questions which Laurier has so "successfully met and satisfactorily settled?"

NOTES AND COMMENTS

—Belgium is participating fully in the worldwide trade revival. Trade throughout the kingdom has not been as prosperous as it is now since 1873.

—It is suggested that the reason why the Liberals desire the proposed change in the constitution of the Senate of Canada is that a deal hatched in the caucus of the Government party in the Commons, sanctioned by the Senate, would have a veneer of respectability that the majority of the Lower House never could give it.

—In the course of his speech last week Sir Richard Cartwright put in a word for the Canadian High Jointers. "I think," he said, "I may say to this House that my hon. friend Sir Wilfrid Laurier, who sits beside me, and Sir Louis Davies, who sits beside me, and myself are just as likely to maintain the honor and dignity of the people of Canada as any three hon. gentlemen that can be selected from the House." Sir Richard evidently believes that "it is well to have a good opinion of oneself." But why does Sir Richard omit mention of Mr. Charlton, who is said to be the most competent of the Canadian Commissioners? It is possible that Mr. Charlton is despised because he has not a handle to his name!

Reply to "Resident."

SIR,—I notice in the WEEKLY EXAMINER of last week an article signed "Resident," in which he makes some very misleading statements, and a very weak argument, in reference to an article written by me and published in THE EXAMINER of the 17th inst. I am informed that he is not a resident of Sturgeon, but was a tool for some who wished to pervert or misconstrue my statements. Why did he not come out like a man and sign his own name. He tries to whitewash and push over the affair so as to give it a decent appearance. If he did not know the facts of the case he should have kept silent, for silence is a noble gift. He has undertaken *moto proprio* or at the accord of others, to vindicate the gossippers and liars of Sturgeon, the respectable and upright people can vindicate themselves. In his letter he says, "His letter conveys the impression that the people of Sturgeon are noted for circulating false stories; it only refers to the gossippers and liars, not the respectable and upright; but what I do say is this, the gossippers and liars are noted for circulating false stories. Again he says,—"If Mr. Kiely thinks he has been slandered he should have recourse to law. Did I not say in my last article that I did not wish to be anywise rash or hasty in the matter, but thought I would give them a word of warning through the columns of your valuable paper. If the law they seek I am right on their heels. He further says, "Instead of slandering a whole community." He evidently tried to convey the impression that I slandered a whole community, but if he will carefully read my last letter he will find to his surprise that I merely referred to the liars and gossippers of Sturgeon, whom I well know, and not the upright and respectable people; and if he was really a resident of Sturgeon he could tell from experience the liars and gossippers from the respectable and upright. It takes more than two or three people to form a community. I do not doubt for one minute that there are as respectable and upright people in Sturgeon as in any other place; but there are some most notorious liars and gossippers also, and it Mr. "Resident" is anxious to know their names he can do so by calling at my office. But I wish him to come during office hours. He further states "False stories are generally harmless and are disregarded by all sensible men." Yes, generally, but not always, as in my case. He tried to pervert my statements, and to my mind champions the cause of gossippers and liars. Who is more dreaded than a liar? I did not wish any one to wear the cap whose head it did not fit. I regard bad stories as *malum prohibitum*. In proof of this we have only to turn to the commandments of God, where He says, "Thou shalt not bear false witness against thy neighbor." Then Mr. "Resident" says false stories are harmless. He makes very light of a lie; but a tiger is always fond of her young, which is only natural. I regard Mr. "Resident's" letter as *bentum fulmen* and very misleading. Beware, liars and gossippers; take a little warning, for if you don't you may have to accept it after it has been dearly bought. For I will follow you, *sente que conte*. He also says, "Because he thinks some one has been telling lies about him," I wish Mr. "Resident" to understand I do not think at all—I am certain; and if he had come out like a man and signed his own name I would have told him their names. But since he did not, he will have to call at my office for further information if desired.

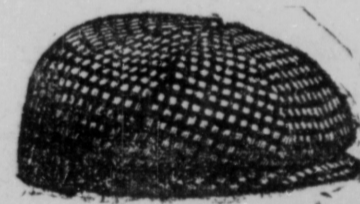
