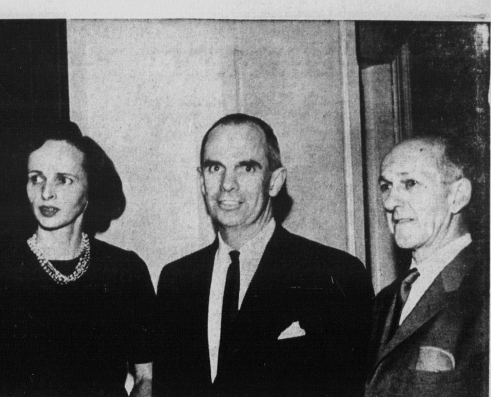


Prayer Week Service Held At Margate

On completion of the morning hearing the case was adjourned until Jan. 20. It was stated that a man is entitled to have any quantity of liquor on the premises as long as he has the money and a permit.

He stated that two young men, later identified to be from the O'Leary area were seen coming up Al Street and going into Gallant's home. As a result two of them were apprehended shortly after liquor was taken from them.

Abegweit Crew Rescues S'ide Boy From Ice Cake

S'ide Bureau. The Guardian Summerside. Sixteen-year-old Kenneth Blaquiere was safely home with his family in Summerside last night after being rescued by the crew of the CNR ferry Abegweit.

Kenneth spent eight terrifying hours adrift on an icepan off Summerside Tuesday night, and was picked up by the Abegweit early yesterday morning as the ice on which he was floating was in the process of breaking up.

Kenneth and another friend had gone smelt fishing from a shack on the ice in Summerside harbor Tuesday evening. Suddenly the ice on which the shack was located broke apart. The 16-year-old boy, George Paynter, reached safety, but Kenneth disappeared in the darkness.

The Abegweit was called in from her berth at Bowdoin at 2:16 a.m. Wednesday. Says Captain Keen: "I worked out where I thought he would be, taking into account the currents and wind direction. We sailed off to a point about 10 miles off Sea Cow Head, near Summerside. It was dark and foggy, and there was some snow. The radar set picked up the shack while we were still two miles away. It was only a 100 yards or so from where I had estimated it would be."

BREAKING UP FAST
"By now the shack was two and a half miles off-shore, and the ice was breaking up fast. Two other shacks on the ice had already tipped over, and it would not have been very long before the shack would have broken up."

WE PRAYED SAYS MOTHER OF S'IDE BOY

Who does it seem like to have your son missing?
Mrs. Aubin Blaquiere, mother of Kenneth Blaquiere, the 16-year-old child plucked from the clutches of death in Northumberland Strait Tuesday night after he drifted out on an icepan, said yesterday morning that a Tuesday evening she was at a bingo party.

She was walking home with another woman about 10 o'clock and noticed a crowd from the waterfront, so we walked down. Some one told me a boy by the name of Blaquiere was adrift on an icepan, and I found out shortly after that it was my son Kenneth."

Blaquiere said she never gave up hope, but at times felt that her son couldn't possibly be still alive as the ice would definitely break up. "We prayed," she said, "and I think that's what saved him."

He must have nerves of steel, because he knew that the piece of ice he was on could not last much longer. We threw him a lifebuoy, and he was able to hold on. We gave him a hot meal straight away, but he still seemed much affected by the ordeal."

IS COMMENDED
Captain Keen has received many commendations on the rescue carried out by him and his crew. Captain Keen and his crew carried out the rescue in the highest traditions of the sea. The skill and promptness with which they saved this boy from almost certain death, and I am happy to congratulate them on the successful outcome of their mission of mercy."

IN QUANDRY
The first word of hope, which was the most much-awaited news of a safe recovery of the young lad came to shore shortly after 3:30 a.m. when the ship radioed to an RCMP car on the scene that they had picked up the lad. The actual pickup came at 3:52, just one hour and 18 minutes after the Abegweit left dock.

The sighs of relief that went up from the large throng gathered around the RCMP radio car was clearly audible. Many had obviously given up hope of the boy's rescue.

Interviewed following the rescue, Abegweit's Captain S. G. Keen said he was able to ascertain an approximate fix on the boy's location as soon as he was told the time of his disappearance through knowledge of the flow of the tides and the wind direction (it was south).

Proceeding via radar, the ship steamed to a spot and a half miles off Sea Cow Head and about four miles from MacCallum Point, where the boy was found.

The almost complete accuracy of the RCMP officers' plan of their course was borne out by Capt. Keen's statement: "If we had stayed on course, we'd have run right over him."

Captain Keen said "I'm tickled to death that we rescued the boy. He might have been dead. We found him only four degrees off our original course. Time was of the utmost importance. He was just floating out with the flow until the half hour could have been the end."

Blaquiere was BAD
Captain Keen said the weather was quite bad, with 25 m.p.h. winds in open water and near zero visibility. The large ice pan on which Blaquiere was found originally housed four small shacks including his. All these shacks remained together with the flow until the Abegweit broke up the ice.
