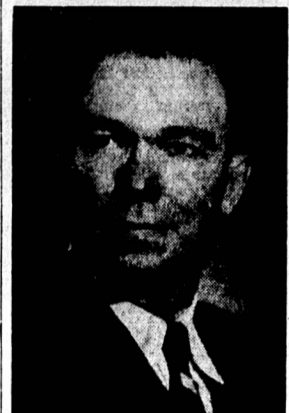

Reviews History Of PEI Health Activities



Dr. Owen Curtis, Deputy Minister of Health, (above), was the speaker at Rotary yesterday and gave a comprehensive review of the various branches comprising the department. Mentioning the fact that the Department of Health and Welfare is one of the largest spending departments of the Provincial Government, he said that to everyone health is the most important thing and if this is lacking in an individual or a country not much else matters.

The formation of the department was primarily brought about by the startling number of deaths in infants and young people and because of epidemics. Department of Health used the latest scientific knowledge and during recent years the mortality rate has decreased and epidemics have been few and far between.

Up to 1763 when the British took over the Province the population is believed to have risen to about 6000 persons. During the

A very beautiful book commemorating the 50th anniversary of the end of the South African war in 1902 was exhibited at this meeting and it was decided to order enough additional copies of the book that one may be given to each of the surviving South African veterans in our province. They will be sent with the compliments of the Royal Edward Chapter.

100 folders have been sent by Dr. Dakin to the Chapter to be distributed by them, in which is explained the use of "Care" parcels for overseas sufferers. It is hoped that by understanding it better, people may use this method more.

The Regent read a letter of thanks from Mrs. Dow, leader of the Donaldson School which the Chapter have adopted and to which they have already sent a school library, a picture and a calendar, all of which were greatly appreciated.

Mrs. Murley reported for the new Canadians and spoke of help that would be welcomed for two very worthy families in the community who are finding it hard to get started in a new land. The members hope to send boxes of clothing to them in the near future.

Miss Fullerton reported for "Empire and World Affairs". She has chosen a committee to work with her, one of whom, Mrs. E. S. Coffin read an excellent article on "Monarchy" as a symbol of unity and of continuity. It linked us to 1000 years of history and to each other.

The national annual meeting will be held this year at Niagara Falls from May 31st to June 4th inclusive. The annual Rose Day Sale will be held late in May. The roses for this sale are purchased from disabled veterans and the sale is for both them and us. The meeting closed with the National Anthem.

Busy Period For PEI Travel Bureau

A total of 1217 queries were received by the Prince Edward Island Tourist and Information Bureau during the month of March. This was several hundred higher than for the same month last year. Letters of inquiry for literature totalled 831. In addition the Bureau received 368 letters from school children who requested literature to be used in class projects. Of the number who asked for literature, 195 stated they would be vacationing in Prince Edward Island this summer. The number from the United States who plan to spend a holiday here totalled 109. The March mail brought definite word from 86 Canadians who plan to holiday on the Island this summer. LEAVES FOR OTTAWA — Hon. C. C. Baker, Provincial Minister of Agriculture left yesterday by air for Ottawa. While in Ottawa he will attend a meeting with the Federal Minister and other Provincial Ministers of the Department of Agriculture. He is expected back Thursday or Friday this week.

COUNTY MAGISTRATE'S COURT — Two truck drivers, residents of Brookfield and Cornwall respectively were convicted yesterday of operating overweight trucks on public highways by the Queen's County Magistrate, Mr. Gilbert A. Gaudet. They were both fined \$40 and costs or in default 1 month imprisonment.

CARS COLLIDE — A collision involving two automobiles occurred on Grafton Street near the Prince Edward Theatre yesterday morning. The accident happened when a car going west on that street reportedly collided with another which was backing out from a parking space. Considerable damage was sustained by the first car. The other car was slightly damaged. No injuries were reported.

ISLAND REPRESENTATIVES — Mrs. G. S. Inman and Mrs. Russell Roper will represent the Liberal women of Prince Edward Island during a two day special general meeting of the National Federation of Liberal Women of Canada. The two day meeting will be held at the Chateau Laurier Hotel in Ottawa and will commence April 1st. Mrs. Inman is president of the Provincial Liberal Women's Organization here.

PROGRESS REPORTED — The new building that will house the dial system and offices of the Island Telephone Company in this land is expected to be completed sometime in June it was announced by officials of the company yesterday. Dialing equipment for the project is expected to arrive in November. It is believed that the actual installation of the dial system will take about six or seven months. A toll dial system, parts of Nova Scotia has been in operation for the past month.

PLOWS IN KING'S COUNTY — A reply to a question asked by Mr. John A. MacDonald in the Legislature was tabled yesterday by the Minister of Public Works and Highways. The reply stated that during the past winter there had been eight plows permanently in King's County. They were located at St. Peter's, Morell, Annandale, Souris, Montague and Murray River. It also revealed that rentals of \$100 in each case are being paid for storage of the plows to Morell Co-operative, P. A. Peters and John Ferguson.

BREEDERS' MEETING — Plans for the use of the government grant were discussed by members of the Prince Edward Island Guernsey Breeders Association during a meeting held Saturday at the Dominion Department of Agriculture building. A plan for submission to the Department of Agriculture was drawn up during the meeting. A report was given to the meeting on the two pure bred sires which were imported from Ontario last year. One, "Cairpat Nible's Prince" was purchased from J. Milligan and Sons of Whitby, Ontario. He is at Harold Laird's farm in Kelvin. The other was purchased from Kingfield Farm owned by C. F. W. Burns. Both animals were sired by MacDonald's Farm's "Fore Nible" purchased in 1949 for \$7,000.

POLICE COURT — Seventeen men and one woman were arraigned before the Stipendiary Magistrate at the City Police Court yesterday morning. The woman was convicted of being drunk and incapable and was sentenced to \$10 and costs or 10 days. Ten men were charged with being drunk and incapable. Four were sentenced to \$5 and costs or 5 days, two were sentenced to \$10 and costs or 10 days, another received a 20 days jail sentence and another was fined \$20 and costs or 20 days. Two more had their cases adjourned, one until April 3rd, and the other one week. A man charged with being drunk and disorderly was sentenced to \$10 and costs or 10 days, and another charged with the same misdemeanor was dismissed. The case of a man charged with vagrancy was remanded until April 3rd, and the case of a man charged with drunk driving was remanded until April 5th. Three men were charged with being drunk and incapable also appeared for trial. One was sentenced to \$30 and costs or 30 days, another to \$20 and costs or 20 days, and the case of the third was adjourned until today.

Will Operate Service To Newfoundland



Commencing about May 1st the Blue Peter Steamships, Limited, of St. John's, Newfoundland, will operate a regular fortnightly service from Charlottetown to St. Pierre and St. John's, it was disclosed here today.

The Newfoundland Shipping Service in Charlottetown, which operated the M. V. Eskimo for the Prince Edward Island Industrial Corporation, will be agents for the vessel to be used in this new interprovincial service, the M. V. Blue Prince.

The Blue Prince is a modern, all-steel vessel of 700 gross tons with a capacity of 36,000 bale cubic cargo. It is a refrigerated

Violinist Gives Fine Performance At College Hall

The large Community Concert audience sat enthralled for almost two and a half hours last evening as it listened to the exquisite music of violinist Yirah Neaman. Still in his twenties, Mr. Neaman has won recognition in many countries of the world, and since his first American tour in 1948 has appeared in this country each year. He is possessed of a vivid and compelling personality, and in his playing last evening showed complete mastery of his instrument, and a profound and sympathetic understanding of his music.

After the tremendous applause had called for a fifth encore, Mr. Neaman appeared on the stage and smiling at his audience asked, "May I just play one more?" in a manner which suggested they were doing him a favor by letting him play for them. After another burst of applause he offered Debussy's "Claire de Lune", with his violin muted, giving the already lovely melody new beauty. One of the highlights of the evening was the scintillating and extremely difficult "Waltz-Caprice" by Ysaye, arranged by Saint-Saens. This composer was a sensation in the last century and known for his heroic style and also his expression of delicate and tender moods in his "Waltz-Caprice" the artist brought out these talents of the composer to the fullest degree.

Mozart Sonata With Mr. Norman Voelcker at the piano, the artist also offered Mozart's only Sonata for piano and violin, "The Sonata in E minor", which is also the only Sonata this composer ever wrote in a minor key. This number is almost a conversation piece between the two instruments, with the piano picking up a phrase taken by the violin, and at other times joining in a melody which is being used on the strings. The artist's last evening brought out its beautiful simplicity and the strain of sadness which flows throughout.

One of the more taxing numbers offered by Mr. Neaman was the "Nocturne and Tarentelle" by Karol Szymanowski which was the concluding number on his programme. This Polish composer has embodied in his music the wild beauties of nature coupled with his outstanding artistic instincts, and his music varies from passages of wild, beautiful grandeur, to phrases of haunting sadness.

It was regretted last evening that the regular programmes for the performance had not arrived from the printer, and the substitute sheets offered to the audience did not give details of each number. Although this did detract for some, to others it gave the advantage of being able to lose themselves completely in the music.

Other Selections Other selections included in the evening which will long be remembered by all those in attendance were "Introduction and Capriccio" by Antonio Vivaldi, arranged by Ferguson; "The haunting and familiar "Air on the G String" by Bach, arranged by Wilhelm; "Rondo" by von Weber, arranged by Helfetz; Paganini's beautiful "Caprice No. 24"; Schubert's "Rondo", arranged by Rostal; "Melody" by Tchaikovsky, arranged by Flesch, and Ibert's familiar "Little White Donkey."

In addition to proving a most competent accompanist, Mr. Voelcker offered a group of two piano selections which met with tremendous applause. It was his encore however, "Prelude in G minor" by Rachmaninoff, which proved the highlight of his all too brief solo performance. Others which he played previously were Bach's Chorale-Prelude: "Jesu, Joy of Man's Destrining", arranged by Hess, and Ravel's beautiful "Jeux d'eau".

Resources Survey For P. E. I. Urged By Provincial Treasurer

"I believe the time has come when some careful assessment of our resources, actual and potential, must be made," Hon. W. E. Darby, Provincial Treasurer, told the Legislature last night in the course of his address on the Budget.

"It is an historic fact," Mr. Darby noted, "that no geologic survey of this Province has been made since 1883. With all the technical devices now available to aid in survey work, in contradistinction to what must have been an almost superficial examination in those early days, who can tell what products chemical or mineral might not be revealed capable of successful exploitation?"

"We see no reason why federal facilities and personnel should not now be engaged in such a survey. Their services are available and we should press for immediate action. I believe the Federal Department of Industry and Resources would be glad to co-operate."

"We must, however, overcome that spirit of negation which seems to have dominated our thinking. I believe we can accomplish great things if we but chart our course based on the firm conviction that our primary industries are sound and prosperous and should be attractive to our youth, and that growth and expansion is possible in many other lines of endeavour."

Successful Ventures "That we are not lacking in either industrial enterprise or enterprising industrialists is amply demonstrated by the successful business ventures presently being operated here and against active general competition. "True, we are somewhat hampered by lack of cheap power and lack of an adequate and continu-
