One writer says, "there have been blunders here, and no mistake; a tremendous waste of Government property, which Englishmen will have to pay for. The mules have been dying by scores, and the horses, purely of want of water. They have been landed with nobody to look after them, wandering about the country looking for water and provisions, and falling down dead from sheer exhaustion. Go where you will, for miles around, and you see nothing but carcasses of dead horses and mules." It is to be feared, after all, that we have gained little by our Crimean experiences.—London paper.

On examination a deep cut was found on the back of his head, caused probably by a fall. He was picked up and carried to his residence in Barrington street, but has not yet been able to give any account of the cause of the accident.—H. paper.

The girl purchased half a pint of vitriol, sent for Hayes, and as soon as he entered her apartment she threw the liquid in his face. He was fearfully burned, one eye being entirely destroyed. The girl was arrested, but expressed no contrition for the act; on the contrary, she said she had "revenge so far, but was not yet content."
