

UPEI'S Apartheid Connection: To Be Or Not To Be

On January 12, 1986, the Student Union banned the sale of Carling O'Keefe products in the Student Union Building. Carling O'Keefe is controlled by Rothman's Canada, a subsidiary of Rothman's Pall Mall International, which in turn is controlled by the Oppenheimer Group, the largest consortium in South Africa. Since the UPEISU ban began, Student Unions across the country who made the same decision have been re-evaluating their stand. The UPEI Student Union is about to do the same.

The question is one of principles and one of direct ramifications. The decision to ban was originally made by Council to uphold a principle: the principle of opposition to the Apartheid policy of the South African government, and the Oppenheimer Group's participation in that social system. The local ramifications are the loss of potential sponsorship from Carling O'Keefe for Student Union events (in the form of donated Miller and Carls-

berg products), and the absence of Miller and Carlsberg beer sales and Rothmans cigarette sales in the Student Union building.

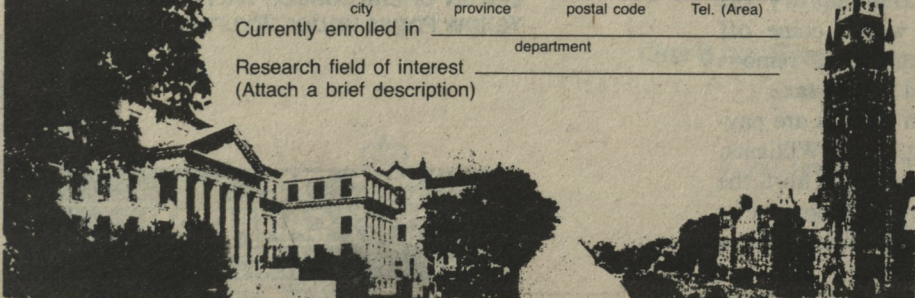

Do you want to be a doctor? A lawyer? Do you want to know why the liquor prices in the Panther Lounge are what they are, or do you want to change them? This is your chance!

There are several positions available on Student Union committees. They include:

i) **Panther Lounge Management Committee:** One more student will be selected to serve on this committee. If you are a student, and you are interested in the Panther Lounge, then you are eligible. Here's your chance to have some direct input into the decisions made regarding the operations of the Lounge. If interested, leave your name and number at the Student Union office or S.U. Information Desk in the Library Lounge, or with any Student Council member.

ii) **Health Plan Review Committee:** The Student Union will soon be evaluating its Health Plan, which is currently administered by Blue Cross. At least two other companies want the contract for the administration of the UPEISU Health Plan. Thus, this com-

mittee will be making recommendations to Council regarding the Health Plan: which company should be administering it, what medical items should be covered by such a plan, should birth-control pills be included in the coverage (as they currently are, at a cost of \$8 or \$10 per student per year, whether you use them or not). Again, if interested, leave your name and phone number at the S.U. Office, at the Info Desk, or with a Councillor.

iii) **Student Judicial Committee:** Two more students are needed to fill this committee: one freshman and one sophomore. Members of this committee will be asked to serve as "judges" over cases in which rules have been broken in the Barn. So, if a Panther Lounge patron punches out a window in a drunken stupor, this committee decides what disciplinary action is necessary. Committee members will be chosen by the Student Union Hiring and Selection Board. Applications must be filled out by interested students. These can be picked up at the S.U. office, 9:00 am to 4:00 pm, or at the S.U. Info Desk.
