The CPR contends it would lose around \$5,200,000 and the CNR about \$2,600,000 a year.

"We cannot with the best of good-will," the chief commissioner said, "devise an equalization system, that will work out to maintain revenues to the decimal point for each railway. Because of their different patterns of traffic, someone is going to get a little less or a little too much. But we are going to try to devise a method that will make the discrepancy as small as possible."

Transport Bd. Replies To Rates Criticisms

Ottawa, (CP)—Canada's new scale of equalized freight rate will be made as fair as possible to all regions and to the railways, Mr. Justice J. D. Kearney, chief commissioner of the board of transport commissioners, said Thursday.

The transport board head, who announced Monday a new tolls setup will go into effect Jan. 1, 1955, was replying to criticisms of tentative new rate schedules made public by the board 10 months ago.

He indicated the board may to some extent relax its proposals to meet objections raised by the railways, who contend it would cost them millions of dollars, and by business interests in different parts of the country.

The chief commissioner referred particularly to a proposal of the board to wipe out "blanket" rates afforded a huge triangle bounded by Montreal, Windsor, Ont. and Sudbury, Ont. For more than a half-century, all points in this territory have had the same freight charges to and from the West.

Under the tentative equalization plan worked out under a 1951 statute, the "class ceiling rates" between the West and centres in the triangle would be on a straight mileage basis.

Tentative Judgment Thursday, Mr. Justice Kearney emphasized to an equalization hearing that the board's judgment was a tentative one.

"We do not want to do anything," he said, "where the remedy would do more damage than good."

"We know that this is a delicate and difficult problem," he added. "We will look very carefully before we leap, and we will do what we consider fairest to all."

He added that there seemed to be general agreement that something could be done about this particular aspect of the rate structure.

Mr. Justice Kearney noted that both railways argued that the board's proposed class rate scale would cut into their revenues and that both the CNR and CPR have brought forward alternative scales showing higher estimated revenues for them.

ALDREN MEARNS CARVER Friends were grieved to learn of the death of Aldren Mearns Carver at his home in Vernon River on July 10.

The late Mr. Carver was born at Pownal, P. E. I., on December 9th, 1886, a son of the late William and Clementine Carver.
