3 Appeals Dismissed, 4th Charge Reduced

Four appeals were heard in the Appeal Division Supreme Court yesterday with three of them being dismissed and the fourth case in the fourth case, the original charge was reduced by the presiding judge, Mr. Justice R.H. Bell.

The appeal of Vernon G. Riley, Charlottetown, against a conviction and sentence on a drunken driving charge was not allowed. But Mr. Justice Bell reduced the charge to one of driving while impaired and fined Riley \$30 and costs of 30 days.

Defence Counsel Lester O'Donnell contended there was lack of evidence that the accused was a driver of the car, while Crown Prosecutor Allan K. Skelton refuted this argument. Riley was convicted on the lesser charge and fined.

Two other appeals, against convictions on impaired driving charges, by Bernard McGuigan and Henry W. Keating, both of Charlottetown, were dismissed. A \$100 fine and costs were also imposed, and the fine allowed to stand.

The appeal of James Steele, Charlottetown, of a conviction on a charge of driving while his licence was suspended, was also dismissed, and the fine allowed to stand.

Property Damage Case Is Adjourned To Dec. 4

Former Ch'town Resident Dies

With nearly 35 spectators crowding the courtroom gallery, the case of damage to property valued at more than \$50 against Robert Gessner Silliphant, Hunter River, was further adjourned last night after Magistrate James B. Johnston, Q.C. felt that another witness should be called.

Magistrate Johnston, after hearing the evidence for the defence last night, said "before this case is closed I feel that the accused's father (William Silliphant) should be called to give evidence. I think he has a very important part in this case."

The charge arose from an incident in September when the accused is alleged to have driven his truck into the front of a garage belonging to Harold Robert Ford, Hunter River. Silliphant claims that the garage belonged to him and not to Ford. Ford is claiming that he bought the garage from Silliphant's father. Silliphant said the father died last night after Magistrate Johnston is Charles R. MacQuaid.

Major Work Completed At DOT Wharf
Major work on the new department of transport wharf in Charlottetown is completed, Elve Stewart, public works engineer in charge of the project announced yesterday.

However, Mr. Stewart noted that there are many smaller details yet to be completed and it would be some time before a tentative deadline could be set. The original target date was a Nov. 30 for completion.

Tenders for the new stores and shop buildings on the wharf have not been called yet, as the buildings have not been finalized.

The tender system around the perimeter of the wharf is not yet completely some time ago. The concrete deck is almost finished and most of the electric installations and other incidentals have been completed.

There has been no official statement of what will be done with the old wharf that has been used for many years by the transport department, but informed speculation suggests that it may be turned over to the department of public works, believed to be in need of wharf and building space.

Church's Role In Today's Society Is Address Topic

"The church and today's affluent society" was the subject of an address to the Rotary Club which he told him trying some of the weekly luncheon meeting in the Charlottetown Hotel yesterday during rush hours." Mr. Matchem, DD, moderator of the United Church of Canada, said this is a time of revolutions, of ferment and change. Mr. Matchem said: "population explosion, rapid social change, the shift from a rural to an industrial economy, from farm to city. Every generation is an all-pervading sense of fear arising from the ever-present danger of universal destruction. It is a time of threat and promise in which life, like the man most loath to control the threat and to realize the promise."

The speaker continued: "The Christian religion has had many experiences with revolutions. Its first century had hardly begun when those who were first called Christians at Antioch were accused of turning the world upside down." "The speaker described Christian church changes, adding: "It is not too much to say that in common with other governments in the world today, the Christian Church is now entering its fourth period."

"This time is called the 'monocultural Era' marking the power of complete destruction of himself and his world. It is this terrible fact which underlines the truth that man today and tomorrow must live in an EQUITY SOCIETY."

"Today's society is increasingly an equity society. The citizens must own their homes, their cars, their business or industry. These essentials are not owned outright; rather they are being paid for continually. The equity society has a kinked-upstairs economy: increasing thousands employed in basic work in mines and woods, industries such as steel, cement, aluminum and so on, such as our carrying-carrying, economy kind of society."

"The sixth aspect of today's society is monoculturalism. From now on, as long as mankind survives, it must live with that war that the speaker said in quoting a world authority.

PROMISE OF POWER
"On the other hand, there is the concomitant promise of power, man's most valuable tool in war against want. Unlimited power not dependent on continuing supplies of coal, oil or gas. Power to turn salt water into fresh and to irrigate the wastelands. Power to produce disease-proof crops that will strike down forever the spectre of famine. Power
