Five Escape 'n Collision At Bedeque

SUMMERSIDE — Five persons narrowly escaped serious injury on Sunday afternoon, when two vehicles travelling on the Trans-Canada Highway in Central Bedeque met in a head-on collision.

Frederick Joseph Richards, North Bedeque, his wife and two children were travelling in their car east on the highway under treacherous road conditions when they collided with a 1955 Dodge being driven by James Charles Arsenault, Kingsport.

Mrs. Richards received some facial lacerations, but was not hospitalized as Dr. J. C. Bonnell treated her at the scene of the accident.

Both vehicles were very badly damaged with both engines being driven back into the passenger compartments. The cars were towed away.

The accident was investigated by members of the Borden RCMP detachment.

Black Hawks Dump Hapless Bruins 6-3

CHICAGO (CP - AP) — Stan Mikita, Ron Murphy and Elmer Vasko each scored two goals for Chicago Black Hawks Saturday night in a 6-3 victory over Boston Bruins in a National Hockey League game.

The triumph was the fourth straight for the soaring Black Hawks, and tightened their hold on third place.

The last-place Bruins were blanked by Chicago goalkeeper Glenn Hall until almost the midpoint of the third period. Then Johnny Bucyk, Tommy Williams and Jerry Toppazzini scored in that order.

For Williams, an American-born rookie with the Bruins, it was his third NHL goal since going called up to a golf course three weeks ago. He has scored all three against Chicago, getting his first pair a week ago.

Mikita set the Black Hawks on the road to victory with his 16th and 17th goals of the year in the first 10 minutes of play.

The two goals by Vasko, the huge Chicago defenceman, were his first of the season. One came on a long screened shot in the second period and the second in the final second of play after Boston's Bruce Gamble had made a brilliant save on a close-in try by Bobby Hull.

Only Gamble's fine performance kept Chicago from making a runaway of the game. He robbed Mikita three times.

Leafs Top N.Y.; Worsley Injured

TORONTO (CP) — Toronto Maple Leafs banged in two goals in each of the second and third periods, three of them against a substitute goaltender, and cut New York Rangers' two-game winning streak short with a 4-1 National Hockey League victory Saturday night.

Rangers' netminder Gump Worsley hurt his elbow in the first few seconds of the second period and was replaced by Dave Dryden, a junior with no previous professional experience.

Leafs, overcoming their customary first-period doldrums, gave Dryden a rough time and the 20-year-old netminder came up with several outstanding saves against the second-place Toronto club.

The Rangers, in fifth place and fighting to keep in contention for the playoffs, had broken a 10-game losing streak with two victories earlier last week against Boston Bruins but were no match for Toronto.

Their one goal, by Andy Bathgate, was a soft one that any other night Leaf goaltender Johnny Bower would have handled with ease. Bathgate fired a slow 20-foot shot that Bower appeared to have beaten. But when he kicked at it the puck bounced into the net and the New York Winger had posted his 19th goal of the season.

The line of Dave Keon, George Armstrong and Bob Pulford led the Leaf attack. Keon got a goal and two assists, Armstrong a goal and one assist and Pulford two assists. Allan Stanley and Ed Litzenberg got the other Toronto goals.

Worsley suffered his injury just before Armstrong put Toronto into a 1-0 lead after 27 seconds of the middle period. Toronto took possession of the puck at the period-starting faceoff and immediately put on the pressure.

Armstrong got the puck in the corner, swung out in front of the net and Worsley stopped

his shot. Keon got the rebound and Worsley fell to the ice on his elbow trying to stop his shot, which missed the net. The puck got back to Armstrong in front of the net and he flicked it past the kneeling Worsley.

The New York goaltender's injury was diagnosed as a severely bruised elbow. He was to undergo a more thorough examination.

Stanley's goal at 3:12 was a weak shot that slid into the net after missing a flock of players in front of Dryden, who didn't see the puck. Keon made it 3-0 at 7:41 of the third period on a screened slapshot from about 25 feet.

CUSTS MARGIN
Bathgate cut the margin to 3-1 before Litzenberg put the game on ice at 18:54, firing Ron Stewart's rebound in from 15 feet out after Dryden had kicked it right to him.

Leafs took seven of the eight minor penalties called by referee Art Skov. Leafs were two men-short for a minute and six seconds in the second period but Rangers were unable to get a shot on Bower.

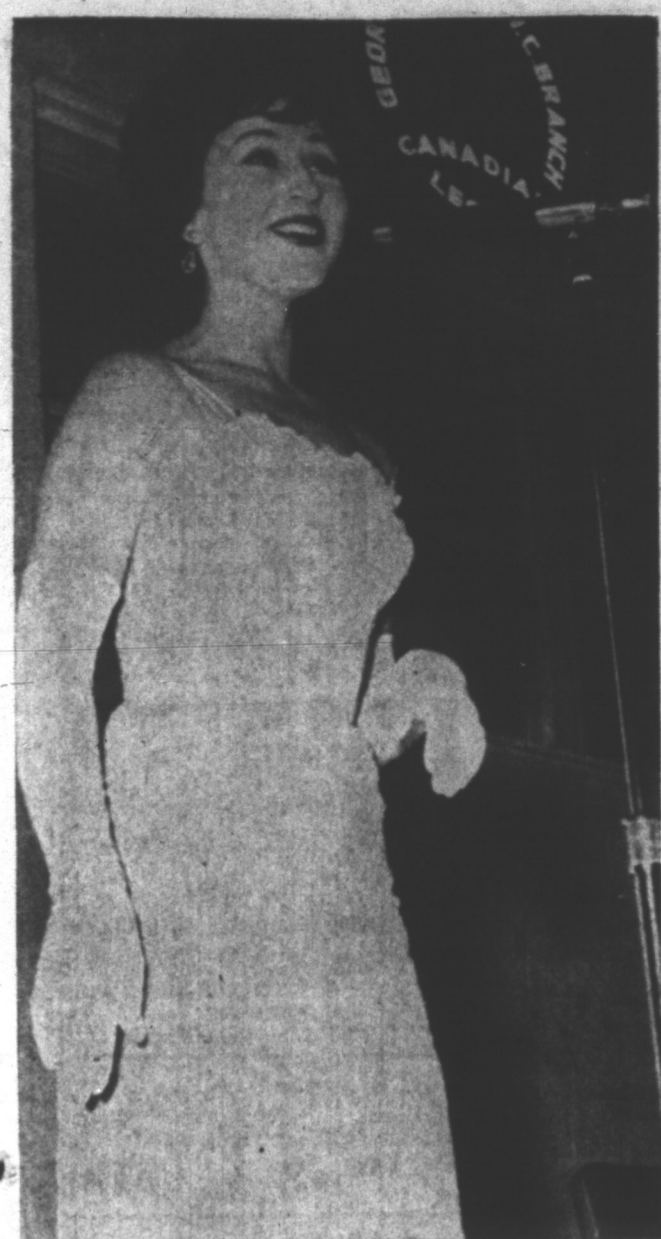
The game started with a bang. As the band was about to play the national anthem, one of the 13,863 spectators tossed a big firecracker at the end of the Leaf bench. Linesman Matt Pavlich, standing at the boards beside the bench, and Toronto defenceman Bobby Baun spent several minutes wiping their stinging eyes.

Dryden, goaltender with Toronto Marlboros of the Metropolitan Toronto Junior A League, and Worsley stopped 33 shots between them compared to 23 saves by Bower.

Centre Red Kelly and defenceman Bobby Baun, both bothered by injuries, both took several turns on the ice.

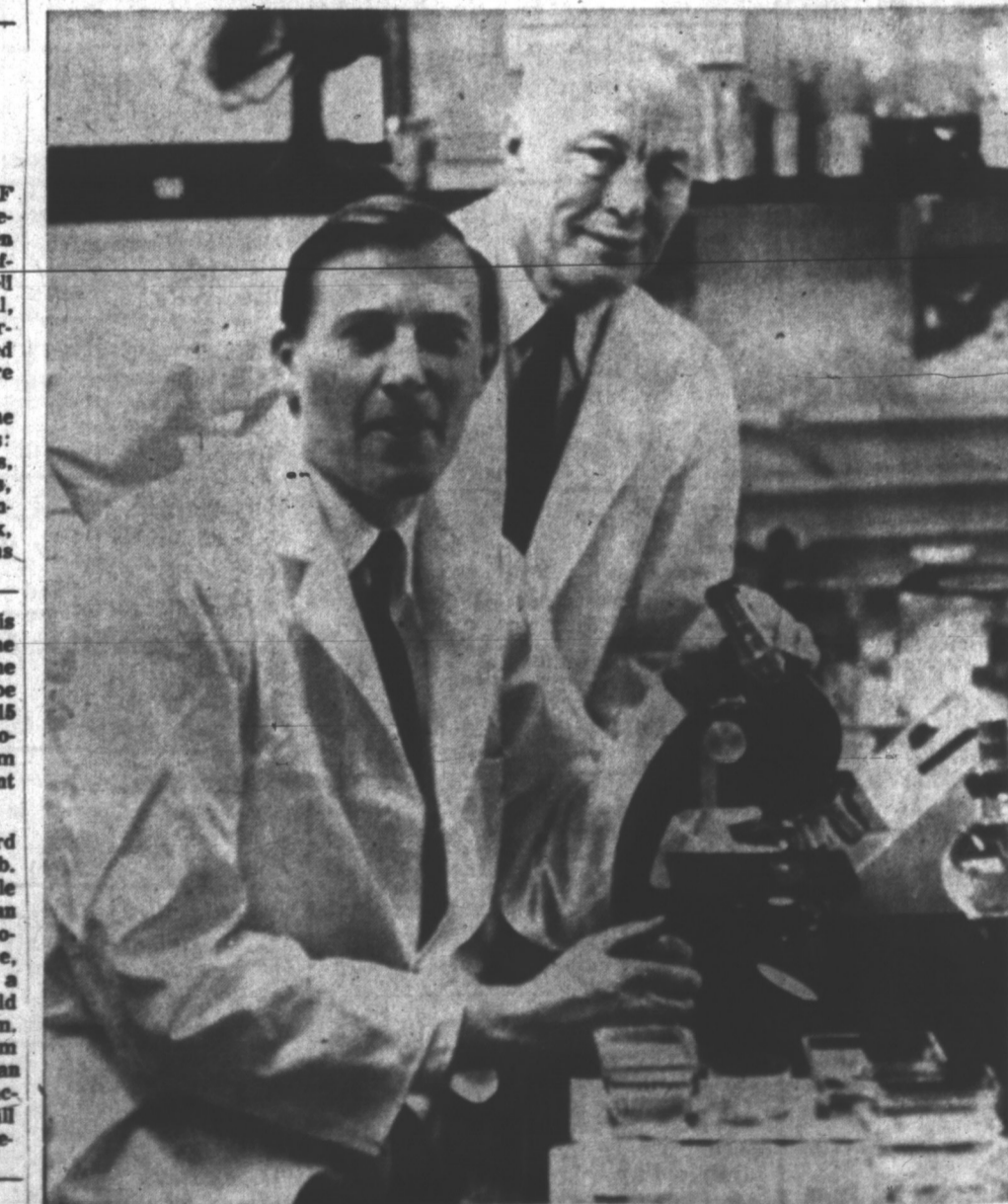

American Motors Head Has Varied Interests

DETROIT (AP) — Between 5 and 6 a.m. on summer days, George Wilcken Romney frequently steps on to a golf course that adjoins his \$100,000 suburban home, tees up three golf balls and whacks them down the fairway.

Then, as rapidly as he can, he follows them up—keeping all three balls in play separately for six holes.

"A compact 18," the father of North American compact cars calls his accelerated version of golf.

Romney attacks a diversified front of public affairs with similar high-compression energy.

He is busy as usual as chairman and president of American Motors, whose Ramblers are pushing for third place in auto industry sales and whose 'Kevlar' division makes household appliances.

He works hard at his position in the Church of Jesus Christ of Latter-day Saints (Mormon)—a post equivalent to that of a bishop.

He organized and heads the non-partisan Citizens for Michigan, aimed at reforms in the state government, and he's plumping for a similar Citizens for America organization.

MAY ENTER POLITICS
He is an elected delegate, one of three vice-presidents and a leading figure in Michigan's current constitutional convention.

And he's seriously considering a bid for the Republican nomination for governor of Michigan. Even before definite word on that from Romney, there was speculation that the governorship might serve as a springboard for a try at the White House. The governor's term ends in 1964, a presidential year, and he's been tabbed as a promising prospect by such Republican chiefs as Richard Nixon and former president Eisenhower.

SPEAKS OUT
At 54, Romney is a handsome man with dark hair becoming grey at the fringes. He weighs 175 pounds, stands 5-11½, has grey eyes and grins broadly and often.

His political attitudes are flexible and he believes in speaking out.

One of Romney's favorite topics is what he considers today's undue concentration of employer, union and governmental power. "We need laws to prevent the aggregation of excessive power in any segment of our society," he says.

URGES REFORMS
He suggests that union bargaining on an industry-wide basis be barred. He would also require, in effect, the break-up of any company engaged in any one basic industry (autos, for instance) and doing more than 25 per cent of the total business (as General Motors and Ford).

The profit-sharing plan he introduced at American Motors—the first of its kind in the industry—received wide attention. The plan was praised by United Auto Workers chief Walter Reuther but coldly received by

Hindu Stargazers Alarmed By Eclipse Of Sun Today

NEW DELHI (AP) — Hindu stargazers, searching a bit harder for their predicted doomsday, warned millions of frightened Indians Sunday night to be prepared for world-ending

calamities today when the serpent Raha slithers across the heavens and swallows the sun. Many astrologers saw nothing to cheer about in the peaceful passing of the first part of their doomsday period that began Saturday.

They called it an ominous warning of horrors to come when the sun is swallowed. To astronomers this will be the moon's eclipse of the sun, involving a rare conjunction of Mercury, Venus, Mars, Jupiter, Saturn and the Earth.

The eclipse will be visible for a brief period in the South Pacific.

The path of the total eclipse will extend south of the Philippines from Borneo through Celebes, New Guinea, and across a stretch of the Pacific.

"What a terrible time the serpent Raha has chosen to devour our protesting sun god," said Swami Yugraj, one of 250 Hindu holy men conducting mass prayer meetings in New Delhi.

"TO SAVE COUNTRIES"
Another Hindu holy man said similar meetings going on throughout India and Nepal were designed to save the two countries from the wrath of the gods.

"Of course, we are praying for the rest of the world, too," he added.

To appease the gods, the Hindu holy men dropped butter and other food in sacred fires. Sporting events went on as usual in India Sunday. But in the back alleys of cities and in rural villages, many men and women spent their time praying.

In the holy city of Benares, there was a rush by pilgrims to bathe in the sacred waters of the Ganges and in temples, priests poured holy water over images.

Even Prime Minister Nehru, openly contemptuous of the astrologers' predictions, found his political campaigning was affected by the conjunction as campaign organizers ran into a shortage of loudspeakers because of a rush by holy men to hire them.

Muslim and Hindu communities throughout the Far East held non-stop prayer sessions and Burmese Prime Minister U Nu set free 602 animals in a symbolic life-saving.
