RECTAL SUPPOSITORIES IN TREATMENT OF MIGRAINE
Several years ago, Dr. Mary O'Sullivan reported her success in treatment of migraine (one-sided headache) by use of ergotamine tartrate. Since that time ergotamine tartrate has been the specific treatment for this distressing ailment in which, in addition to the headache (which is not always one-sided), there are also nausea and vomiting which render the patient unable to leave his room for a couple of days to a week.
Although the exact cause of migraine is unknown, the fact that it occurs in tense, nervous, emotionally hypersensitive individuals with brilliant personalities points to allergy. School-teachers are perhaps the greatest group of sufferers with migraine. When an individual with this type of personality has emotional disturbances, these act as starters in bringing on an attack of migraine.
In Postgraduate Medicine, Dr. Philip E. Zanfagna, Chief of Allergy, Lawrence General Hospital, Lawrence, Mass., in describing an attack of migraine, states that it is generally accepted that the immediate physiologic changes in mi-

Petting Problem Teen-Ager Must Make Boy Respect Her Convictions

DEAR MISS DIX: Recently I have been going with a boy 19-four years older than myself. He, of course, has been around more than I have. What can I do when this boy parks? I like him, but not well enough to neck and pet with him. What can I do as I would like to continue seeing him, but still would like to keep petting out of our friendship?

ANSWER: The petting problem makes its appearance in the early stages of practically every boy-girl friendship, and it is a wise girl, indeed, who learns how to handle it. Such wisdom is by no means dependent upon age. Lassies in their twenties prove themselves completely incapable of dealing with its complexities, yet 15-year-old Nora evinces strong inclinations to keep petting in the background.
In this, as in practically all teen-age problems, your mother would be your best counselor, Nora. It is too bad that so often a barrier exists between mother and daughter that precludes confidences of this sort; it is the fortunate girl whose mother has never let the barrier arise.

GIRL SETS STANDARDS
By the time a girl is old enough to date—which should be about the age of 15—she should also be old enough to realize her responsibilities in handling the petting problem. For on this point, you may be absolutely sure, it is the girl who must set the standards. This is one of her inherent responsibilities.
Since it is easier to forestall trouble than to handle it full blown, the best way to keep control of the petting situation is not to let it get out of hand in the first place. Learn to say a firm "no," on which your escort realizes there will be no compromise. The right type of boy will respect your convictions and refer to them. The wrong type of boy—for you, at least—will indicate quite clearly his unworthiness to be included in your circle of friends.
One thing I would advise, Nora. Apparently your difficulties occur in parked cars. One way to avoid this particular dilemma is to avoid riding with boys, especially at night. If your particular young man persists in parking, simply advise him that henceforth you won't ride in a car with him. He will change his tactics quite speedily, I assure you.
