Directions—*Artificial Slate:* Mix the powder with pure Boiled Lined Oil and a little Spirit of Turpentine to the consistency of very thick Paint, and applying with a common Brush, being careful to keep the mixture well stirred while putting it on. One pound will cover ten square feet with two coats.
