LESSONS OF THE SEASON.

Now that the crops are gathered in for the season, it is a good time to review the year's operations and learn such practical lessons as they have to teach.

Last spring was exceedingly fine and favorable for work, so that crops were got into the soil early and in good order.

Early grain did finely for a while, but the long drought in June stunted it severely.

Later-sown grain made a magnificent crop. Even early grain was a good crop where the soil was rich and deeply cultivated.

Hitherto, in order to escape the "weevil," we have been often compelled to sow wheat before the ground was in a satisfactory condition.

Where properly enriched by pasturing, or manuring in rotation, the oat crop is still a desirable one on most of our farms.

Potatoes have been a good crop, where the beetle was successfully combated.

But growing potatoes for market is not now what it once was. For twenty years, potatoes have been steadily declining in price in the United States markets.

Early and late pasturage this season have been good and a very successful effort of the Dominion Government in establishing these factories on the Island will prove a lasting boon to our farming interests.

WHAT DID IT?

Opinions of Democrats and Republicans on Tuesday's Election. Opinions gathered at Washington on Wednesday show that different men have different opinions concerning the big landslide which has occurred.

Judge Lochren, commissioner of pensions, was interviewed and said: "It is the natural result of hard times. The unthinking classes believe that the Democratic party is responsible for the financial troubles which have recently disturbed the country."

First Assistant Postmaster-General Jones said that the result was due to local causes. It was merely a knock down and not an important victory. He admitted that the election in Ohio was the most important victory for the Republicans and brought McKinley into view as a presidential possibility.

Ex-Senator Mahone, of Virginia, said: "This election has shown that part of the people of the United States have realized that they made a mistake when they put Cleveland in the White House. Both the questions of silver and tariff influenced the result. The people always want a change, and this feeling turns elections the other way. I think that the result is very encouraging to the Republicans, especially in the south."

Wm. J. Bryan (Dem.) says: "If the returns have any significance they indicate that the Democratic party in the northwest has suffered the heaviest losses where its representatives were opposed to silver. We endorsed the position of Senator Sherman on finance, and because of our occupancy of the Republican ground we were repudiated by the Democratic voters. We failed to fight on party lines."

Representative McMillan, of Michigan, said: "I am much surprised at the magnitude of the Republican victory in New York. The general result indicates that the laboring people of the country are opposed to free trade as advocated by the Democratic party. In Ohio the issue was squarely on the tariff, and the enormous victory gained by McKinley shows how strong is the public sentiment on that subject."

Ben. T. Cahoon, of Illinois, manager of the western Democratic branch headquarters at Chicago during the national campaign, said: "Circumstances in Ohio favor the Republicans. The Democratic candidate for governor did not agree with the financial policy of the administration. The fact that this was a general business depression helped along the defeat. The people blame this on the party in power. This depression grew out of the pernicious legislation of the Republic party. The voters will know better at next election."

"THE WEED."

It takes more strength of mind, more firmness of purpose, more decision of character, to break off a bad habit than it does to acquire one.

I knew a man who undertook to give up the use of tobacco. He chewed it—the best Cavendish tobacco. He put his hand in his pocket, took out his plug of tobacco and threw it away, saying as he did so, "That's the end of it."

But it was the beginning of it. Oh, how he did wait! He would lick his lips, he would chew camomile, he would chew gentian, he would chew tooth-pick, quill, anything—keep his jaws going; no use, he suffered intensely.

After enduring the craving for thirty-six or forty-eight hours, he made up his mind: "I will do it. I will give up a bit of tobacco; I will go and get some."

So he went and purchased another plug, and put it in his pocket. "Now," he said, "when I want it awfully I'll take some."

Well, he did want it awfully, and he said he believed that it was God's good Spirit that was striving with him as he held the tobacco in his hand. Looking at it, he said: "I love you. But are you my master, or am I yours? You are a weed and I am a man. You are a thing, and I am a man. You black devil, I'll master you! I'll break you! I never shall be of me again. There is a man mastered by a thing!"

Every time he wanted it he would take it out and talk to it. It was six or eight weeks before he could throw it away and feel easy; but he said the glory of the victory repaid him for all his struggle.

Now, some people say that it is harder to give up tobacco than it is to give up drink. It may be in certain cases. Here is a young man, for instance—"Charley, have a glass of ale?" "No! I don't care for it; I'll take a cigar." And if a man drinks his glass of ale once or twice a week, but takes cigars three or four times in a day—it will be harder for that man to give up the cigars than the drink. The love of tobacco is a mighty strong love—many know that. Ay, and so do I. A physician in Halifax told me a year ago that he had a patient who would not give up tobacco. "Tobacco is killing you," he said to him. It made no difference; he smoked his pipe still. At last a tobacco cancer came upon his lip.

"Now," said the physician, "you are feeling that by your tobacco. No use! He would smoke. An operation was performed, and a painful one, and said the physician: 'I told him I would call in next morning, and twenty-four hours after that operation I found him propped up in bed, with his face bound up on one side and a pipe in the other side of his mouth.' Now, it is 'mighty hard,' as we say, to break off a habit of smoking or of using tobacco; but when the appetite for drink lays hold of a man—what then? Do you know what it is? Too many do. The crying, harrumphing, itching sense—as a man said to me, using a homely expression, 'I felt as if I had an irritating itch in my stomach, and could not get rid of it'—day and night crying—like the leech—for the stimulant: "Give! Give!"

The correspondent also sends word that President Peixoto's recently promulgated decree regarding foreigners regulates their entrance upon Brazilian territory, their residence there and their expulsion during the continuance of martial law in the republic. It also provides rules with regard to the landing of beggars and vagrants or those suffering from contagious diseases. These are prohibited from entering the country.

Sir Charles Hibbert Tupper Interviewed.

HE SPEAKS VERY CLEARLY

Concerning Some of the Statements Made by the Grit Press.

MONTREAL, Nov. 11.

Sir Charles Hibbert Tupper on being interviewed, expressed himself in terms not flattering to the newspaper men who give vent to rumors of personal unpopularity between public men and then seek interviews with these men in the hope of the substantiation of their scandal. He wished to say that Sir John Thompson was not the man to remain in a cabinet when colleagues whose resignations he had in his pocket, nor was there any man in the Government who would remain at variance with any other member of the administration. As a matter of fact, the French treaty has not been rejected by the Government. It was not for the Government to accept or reject it without repudiating the plenipotentiary who has signed it. It was for Parliament to accept or reject it, and there was no need for haste in submitting it to Parliament last session. It was quite possible that there were terms of application to French commerce which might not have been collected by the Government, but he (Sir Charles) could now positively say that it was the intention of the Government to submit the treaty to Parliament for ratification next session.
