Liberal victories were easier to achieve in those days, and Premier Campbell led his party to a 27-3 triumph in 1939. He was Chief Justice, and removed from politics, before the 1943 election was held.

Alexander Campbell was elected to the Provincial Legislature at a by-election in January 1944 when he was elected for the Summerside district, officially known as 5th Prince.

There was no indication last night of any other Liberal offering for the leadership, though that situation could change before convention day.

OTHER SPECULATION

The name of Ira Lewis was suggested by several spokesmen but Mr. Lewis and his brother, Claude, have one of the province's largest farming operations at York and it seems unlikely that he could leave this responsibility to think of such a time-consuming job as party leader, he said.

Dr. Bonnell was first elected to the Provincial Legislature at the general election of 1951. He has been re-elected at every succeeding election. He was minister of health in the A. W. Matheson government from 1955 until the Progressive Conservatives took over the government in 1959.

He was chosen as acting leader by the executive of the Prince Edward Island Liberal Association earlier this year, after A. W. Matheson had tendered his resignation to the party.

Speculation also includes J. Watson MacNaught, federal mines minister who was defeated in the election of Nov. 8. Mr. MacNaught was defeated in a bid for leadership several years ago when the leadership of Mr. Matheson was challenged. But with the added prestige of having held a federal cabinet post, it is possible he might attract more support this time.

Nothing is known definitely about Mr. MacNaught's intentions but some speculation here suggests he is interested in the Senate vacancy for this province. Some more extreme speculation suggests he might be a possibility as a cabinet member, representing this province as a Senate member.

There are precedents for Senators holding cabinet posts. For example Ross MacDonald now Senate leader, was solicitor general for a time when he was first named to the Senate—Mr.

Trade Board Planning Wilmot Tourist Bureau

SUMMERSIDE — Proposed plans for a new tourist bureau at Wilmot were presented to the Board of Trade at its monthly meeting here last night.

The plans, drawn up by architect Keith Pickard, call for a building 20 feet by 30 feet which would be situated on the board's property at Wilmot. Charles Linkletter, who spoke on the proposed project, said the building would cost in the vicinity of \$4,000.

He stated that a request had been placed before the town for \$2,500 to go towards the building. "We don't expect the town to put money into this project except through a grant," he said, "which they would get back through winter works."

Following considerable discussion a motion was passed that the tourist committee and directors of the board be empowered to come forth with a plan for a bureau which would not exceed \$5,000.

The president, Francis MacQuarrie, told the members he had received word from the minister of highways yesterday concerning highway weight restrictions next spring.

He said the minister had stated that, in his opinion, the highway will be treated the same as the all-weather highway without restrictions on trucks. It was

pointed out however, that weight restrictions will be enforced on the stretch of highway from Summerside to Miscouche.

Concern was expressed by all board members over the lack of progress on the industrial park project. The subject was brought up when the rumor of a fertilizer plant being erected at Travellers Rest was mentioned. Board members wanted to know why such a plant could not be situated on the industrial park site. After most of the members present had expressed their views regarding the lack of effort in developing this site, Claude Ives was elected to represent the board at a meeting next Tuesday dealing with the park.

Mr. MacQuarrie told the meeting that he received word from the CNR that rest rooms at Borden and Cape Tormentine will be open 24 hours daily from Dec. 1 until April.

When the subject of downtown parking was brought up Mr. MacQuarrie stated that at a meeting earlier this week Laurie Coles had presented a comprehensive report following an extensive survey on the situation. Further meetings are planned, Mr. MacQuarrie said, to deal with the problem.

The date for the board's annual meeting was set for Jan. 26 last night.

American Commitments Said Top Pillar For World Peace

WASHINGTON (AP) — The "principal pillar of peace in the world," U.S. State Secretary Dean Rusk said Wednesday, is the American commitment in Viet Nam and elsewhere.

If it is not kept, he said, it could lead the Communists to "monstrous miscalculations." Rusk spoke to a windup luncheon of a three-day White House conference on international co-operation. His audience—more than 2,000 men and women leaders in dozens of fields of international affairs.

The secretary defended U.S. policy in Viet Nam as one of toughness, coupled with patience and prudence. He said the United States is in touch with "the other side" regularly "every week," and has found no sign of willingness to take the conflict out of the battlefield and to a conference table.

In both his speech and his replies to written questions from panelists, Rusk attempted to answer and disarm criticism of the U.S. administration's war policy in Viet Nam and the continued U.S. bombings of North Viet Nam.

REFLECT MISGIVINGS — The questions reflected deep misgivings about the role of the U.S. Central Intelligence Agency in foreign affairs, the wisdom of the Viet Nam War and the bombings.

Rusk asked any in the room who thought they have "sure and solid answers" to these complex problems "to approach it somewhat on your knees."

The question, he said, is "how best to establish peace," and added:

"This is a question that makes pygmies of everyone." As to a halt in the bombings as a means of inducing the Communists to open peace negotiations, Rusk said: "I am

not excluding the possibility of stopping the bombing."

But he said "when you sit where I sit it is not necessary to speculate about what the results would be. If we had adequate contact with the other side to know what the reaction would be."

"We are in touch with the other side regularly, every week, Rusk said.

"Our contacts with the other side are completely adequate to the problem of finding out whether the stopping of the bombing would be a step towards peace, whether it would lead to discussions or negotiations."

Rusk pointed out that bombing had been halted briefly once before and "on the third day we had our answer from each of the Communist capitals involved. They did not ask us to extend the halt so they could talk things... They said it was an insult, or they didn't answer."

Clinics In Prince Begin Next Week

"The fifth and last series of Red Cross blood donor clinics for 1965 will be held in five Prince County centres next week," stated F. A. S. Jones, provincial Red Cross blood donor chairman last evening.

Mr. Jones went on to say that the 1,230 objective set for the four days is greater than for any of the other series held during the past year. The chairman explained that this increase was due to the fact that the RCAF Station has requested that another hour be added to the usual three and one-half hour session thus making their total objective 270 donors.

Next week's series will get underway at Borden Legion on Monday afternoon when the clinic hours will be 2 to 4 p.m. and the objective is at least 120 donors in the two-hour period.

J. J. MacIsaac of Borden again heads the blood donor committee there with the Borden branch of the Royal Canadian Legion and the Carleton Siding Women's Institute as the joint sponsors.

Monday evening's clinic takes place at the Legion Home in Kensington under the sponsorship of the Royal Canadian Legion branch there and with Earl Carrier as the chairman for the second successive year.
