DECEMBER 9, 1893. EAST ROYALTY POLL.

We congratulate Sheriff Horne on the change he has made, on his own responsibility, in the location of the poll in the East Royalty. He has brought it in from the Schoolhouse at Brackley Point Road, where it was placed by the Government, to Love's Tannery. Had Mr. Horne allowed his own way in the election, he would have given every satisfaction, and no complaints could have been made.

WHO IS THE MAN?

It is reported about town that the Local Government have appointed a Stipendiary Magistrate in succession to Mr. Fitzgerald, who resigned about two weeks ago to accept the nomination tendered him by the Liberal-Conservative of Charlottetown and Royalty. The name of the appointee, however, has not been made public, nor is it likely that it will until the election is over. No matter who is chosen, many will be disappointed, as there is a great scramble for the position among the lawyers. This latter fact explains the dilatoriness of the Government.

THOSE FLY-SHEETS.

The Patriot continues to complain about certain fly-sheets "with no name signed to them." This complaint is childish. The fly-sheets referred to public facts and figures. If these facts and figures are wrongly stated, or if wrong deductions have been made concerning them, the wrong can easily be pointed out. There can be no doubt that the "campaign literature," to obtain which Mr. L. H. Davies has appealed to the grit party in the course of his long and arduous "circular letter," will be anonymous. But the organs of the Canadian Government will not whine about that point. They will set forth the errors of the compilers.

SIGNIFICANT!

The election, as M. P. for Ottawa, of Sir James Grant by acclamation was not strengthen the idea of some persons of strong imagination that the amount of the debt of this Province incurred by Mr. Peters will be recovered by Mr. Davies when he shall be in a position to assert our claims upon the Dominion treasury. The Mercierite theory will not prevail; for Mr. Laurier and Mr. Davies will not probably be in a position to control the Dominion treasury for many a long year to come. Is it not significant that in the very centre of the political life of Canada no man dared to enter the lists in a contest for the vacant seat in the House of Commons?

THE CONTEST IN THE CITY.

The Government candidates are admittedly men of no experience in legislation and no ability in debate. Suppose the impossible—suppose that the Peters Government be sustained by the voice of the Province—they will, necessarily, and in spite of themselves be as putty in the hands of the mouster, the mouster being a man who has a grudge against the city which twice rejected him.

It matters not which party will be triumphant on the 13th inst., the financial crisis which has been reached will necessitate important financial legislation affecting the interests of the city as well as of the country. It is, therefore, important, in the interests of the taxpayers of Charlottetown, that influential men be elected to represent the city. Such men are Lemuel C. Owen and Rowan R. Fitzgerald. The former has had a long experience in the legislature, and his voice will be heard with respect in the new assembly. The latter is, as a result of his experience in the office of City Recorder and Stipendiary Magistrate, intimately acquainted with the legislative requirements of the city, and is a clear and strong debater, able to uphold the trusts committed to his keeping.

Neither of these men can easily be hounded or over-reached by any political leader. If the Liberal-Conservative party be triumphant—and all signs point to that conclusion—they will assuredly have a potent voice in the formation of the party's policy. It is said that a word to the wife is sufficient. We have no desire to labor the point, and we feel sure that it is not necessary to do so. The interests of Charlottetown at this juncture demand that the electors of Charlottetown shall return Owen and Fitzgerald as their representatives. We hope that the electors of Charlottetown will remember of this and vote accordingly.

The signing of the astute Belfast, that "Ferguson floors him every time," is not admired by Mr. Davies and his friends. But Mr. Davies is evidently not anxious to try conclusions with the well informed Senator. Expressio deest.

OUR MILITIAMEN.

The brilliant triumph of our artillerymen, recorded in another column of THE EXAMINER, following upon their success in the efficiency competition, ought to incline the authorities at Ottawa to respect the militia of the Province. There can be no doubt that we have here the material for first-class soldiers. Both competitions were open to the militiamen of all Canada; and in point of fact, the crack teams of all Canada took part in them. Surely the men who, under unfavorable conditions, won first position in the efficiency competition, and first and second positions in the shifting competitions, deserve encouragement rather than discouragement. Though they are willing and ready to fight for Canada in any part of Canada, they decidedly object to their being attached, as a sort of tag-end to the New Brunswick district. Their success, and the honors which they may win, in peace and in war, ought, they think, to inure to the honor of their own Island home; and we think that their wishes in this respect ought to be consulted.

NORTHWESTERN RED FIFE.

The Northwestern Red Fife which is evidently going to maintain its reputation on the Island. Our crop this season was not so large as last year, but the quality of grain is superior, and the crop was a good one, considering the disadvantages it had to contend with. We sowed on May 5th on land in very inferior condition for working. The grain came up well, and the first of June made a splendid growth, covering the whole field with a waving mantle of deep luxuriant green. But, as the month advanced, the protracted growth took on the vitality of the rapidly growing young plants; they became stunted, shrivelled, and sickly yellow in color, and when they began to bloom on the 4th of July, they were at least a foot shorter in growth than the same wheat of the year before. At this date, however, slight showers of rain began to fall. The blossoming continued for ten days, and under favorable circumstances the grain was set. What a pleasure it was to observe that no myriads of ganzy-winged midges hovered round the yellow bloom to destroy the hope of the future harvest, while the gem by cradled in its silky palisade! More copious showers succeeded, and the stunted spikes were filled with well-developed grains.

We cut before the great storm of August 21st, and so lost none by shelling. After that storm, the weather came bright and dry, and the crop soon went into the barn in magnificent order. This is one important advantage of early sown grain.—It is sure of good weather for harvesting. If a sudden shower does come, it effects disaster like the early due before the powerful sun and dry winds of August; while late September rains often ruin the most luscious harvests. We threshed twenty three bushels to the acre all round. Not a large crop, certainly, but a good one, under the circumstances, and the most grain ever sown from the same growth of straw. This grain, after two years' sowing on the Island, is as hard and firm as the imported seed.

There is now no reason why every farmer on the Island should not grow his own flour. Two or three acres heavily manured for roots and dressed with phosphate will pay all the cost in the crop of roots, and then the ground will be left in the best condition for wheat. Plow in the fall, sow whenever the ground is dry, and you will be sure of 20 to 25 bushels per acre. Three times, this will be ample for any family; and what a comfort to have the flour simply at home instead of buying every pound at the store.

One drawback to Island flour has been its inferior quality, but Northwestern Fife gives the very best grade, as easy to bake as the best imported. With us, a house full of youngsters never tire of consuming the bread and cookies made of it.

Good wheat, however, like everything else, requires good farming. First, the land must be well chosen—the deep rich loam where the giant excelsior birch and sugar maple once clothed the hills with heavy billows of deciduous foliage is the best. When the land is new it should not be exhausted by cropping, but its store of virgin humus conserved by laying it down to grass and pasture with lime. Stock must be kept, and the abundant crops returned in well made manure to the soil. But farmers tell us that stock does not pay. There is no year but some kind of farm stock pays well. At present there is money in pork, and good well-fed dairy stock pays. In computing the profits of stock we must never forget the value of the manure and the disastrous effects of the want of it. Land impoverished by cropping is made still poorer by each succeeding crop. But highly manured land gathers to itself still further riches from the exhaustless stores of the air and mineral constituents within it. Manure may appear costly, but deposited in the soil, it is in nature's bank where it draws ceaseless toll from the various rock constituents, the floating sea of aerial moisture and the components of the atmosphere itself. These it gives up to the growing plants, which in turn enable it to draw still larger stores for future use. One heavy manuring will leave its mark on the land for a hundred years to come and who dare deny to that fair, faithful treasury, that in verdant luxury of grassy meadows, and productive grainfields, and furrow spangled borders and rustling flocks, lies spread round his door, the humble deposit which it requires to return wealth and comfort to himself and his children? PORT AUGUSTUS TEMPERANCE MOVEMENT.

On the 8th inst. the Rev. Allan J. McDonald, P. P., gave a very forcible and pathetic instruction to a very large congregation in the parish church, on the frightful results of intemperance. He referred in feeling terms to the sad and gloomy fate of the two poor men who were drowned at Southport on the night of the 28th ult.,—snatched off in the prime of life. He exhorted his hearers to take heed of this awful warning, and live good, sober, practical lives. He said he was glad to be able to say that since he commenced his mission among them some fifteen years ago, there had not been any liquor sold in Port Augustus, to his knowledge. Still, owing to late circumstances, he had now decided to go a step further and form a "Temperance League of the Holy Family," the conditions of which should be that every member should abstain from the use of liquor. Each member pledges himself not to drink intoxicating liquors in Charlottetown or away from his home. For his own part, he disapproved of the use of liquor, if used at all it should be used as medicine and only as medicine. He wished only those who intended to be consistent and sincere to join. The writer, who was in a back seat, believes that every man present, and the congregation was unusually large, knelt down and took the pledge. And it is beyond a doubt, that such a number of intelligent men, assisted by the Divine aid and guided by the good counsel of their reverend pastor, will become a credit to themselves, an honor to their pastor, and a blessing to the community.

VICTORIA, B. C., Dec. 7.—Steamer advices from Tominia show that Chinese had been reinforced by Siamese soldiers and have vowed vengeance on all. HAMILTON, Ont., Dec. 7.—Col. Thomas Anworthy, the defaulting treasurer of the Ontario Soldiers' Aid Society, has made restitution and afterwards settled here, is dead.

PORTLAND, Dec. 7.—Portland has a genuine case of small pox. George Goodall, aged thirty, has been sick for two days, and the doctors pronounce it an unmistakably small pox. The house where he lives is full of boarders. The places have been quarantined and the police are guarding the house.

MONTREAL, Dec. 7.—Notre Dame Cathedral presented a striking scene this morning, when a solemn requiem mass in honor of the late Marshal McMahon, of France, was held in the chapel in the rear, under the auspices of the French National Society. Old French soldiers in picturesque uniforms were present. The catafalque was surrounded by a body guard from among the officers of local corps. The church was draped in an appropriate manner. Major-General Herbet and a large number of his subordinate officers were present, with the members of the City Council and distinguished citizens. McMahon's requiem mass was sung by Father Colin, who goes to Paris next month, officiated.
