

Winnipeg Site Asset In Air Cargo Field

WINNIPEG (CP)—The Manitoba government is eyeing the emerging air cargo business as a means of converting Winnipeg's long-standing geographical liability into an enviable North American asset.

The city's location near the heart of the continent, a distinct disadvantage in rail and truck transportation, gives such a natural edge in air freight hauling that Industry Minister Gurney Evans says it should be exploited.

The first step in that direction was mooted in the throne speech at the opening of the Manitoba legislature. It promised government action to establish, in concert with private industry, an air cargo terminal at Winnipeg's international airport.

While permissive legislation has not yet been introduced, Mr. Evans sees construction of "a common facility open to all carriers and to all modes of transportation." It would provide for indoor loading and unloading of trucks and trailers "to use air transport in the proper way."

The incentive for both the government and Manitoba industry has been provided by five-year "NEED STIMULATION" But he says Manitoba can't rely on natural growth. It must stimulate the air cargo business because of the inherent advantages that it would bring to Winnipeg.

Projections for future growth indicate that air cargo volume in North America will increase by 240 per cent by 1970 and another 355 per cent by 1975. So far, Winnipeg's percentage increase has surpassed national percentages and Mr. Evans says it is likely to stay ahead even without encouragement.
