DIRECTIONS TO VOTERS

At the Coming Scott Act Election in Charlottetown.

THE Scott Act is now in force in Charlottetown and will remain so until the majority of electors decide otherwise. For the purpose of discontinuing the Act in Charlottetown a petition was presented to the Governor-General praying that the Act should be repealed so far as this city is concerned. The present election is therefore held for the purpose of taking the votes of electors for and against this petition.

The voting will be by ballot, and the following is the form to be used, viz:

OCTOBER 16, 1884.
Voting on the petition to the Governor-General for the repeal of the order in Council bringing into force of the second part of "The Canada Temperance Act, 1878," in the City of Charlottetown.

If the voter is in favor of repealing the Scott Act in Charlottetown he will place a **X** in the upper space alongside of the words, "For the Petition." If in favor of continuing the Scott Act in Charlottetown the voter will place a **X** in the lower space alongside of the words, "Against the Petition."

If the voter places on the ballot paper more than one mark his vote will not be counted.

This election is for the City of Charlottetown only, and we understand that the residents of the County have no votes. It is even doubtful whether non-residents, owning property or paying rent in the city, are entitled to vote. The better opinion seems to be that actual residence in Charlottetown or Common is necessary to entitle a person (otherwise qualified) to vote.

People here are busily engaged in securing their harvest which is proving to be far better than was expected.
The people here are suffering from that painful disease known as diarrhoea or as some call it "the cholera."
Mr. Malcolm Shaw, blacksmith, has returned from Boston with his wife and child and has moved his shop to Brae Station, and has taken up his residence there.
Some of the young folks here are making themselves happy by joining in the bonds of wedlock. The happy ones are Mr. W. Beer and Miss B. I. Campbell, and John Reid and Miss Catherine Gain, all of this place.
A first-class picnic was held at Mr. W. T. Rogers by the members of Perseverance Division, and full details of the same were sent to the Pioneer office for publication, accompanied by other notes concerning rum-selling, and the commissioners appointed to look after the same. These notes were sent by a correspondent from Brae Station, but nothing appeared in the said paper only the soft parts of the notes concerning rum selling, etc., and nothing whatever about the picnic.
Now a few words about the liquor traffic. We have two rum holes here going at full blast from Monday morning till Sunday night, notwithstanding the fact that has been done to put down the illicit sale of that poisonous stuff called whiskey, gin and rum. I suppose people will think that there cannot be many temperance men here, when the fact is known that there are two rum shops kept up here; but it is not the people of this settlement who are doing all the drinking. There is no doubt they do drink a considerable lot, but it is foreigners who are the chief customers—men from other parts, who work in the factories around the shore.
Hon. Peter Gavin has been running a shipyard, lobster factory and saw mill. He has lost heavily just by the rum sold to his men. They would be all on the spree from Saturday night till Monday morning; therefore, when they were wanted to be at their post, they would be more like dead men than anything else. So, after putting up with a great deal of such doings, he got angry, and talked to these rum sellers pretty harshly, and threatened to report them to the proper authorities if they would not stop selling. But they paid no attention to him; so it seems he did write to some of the Commissioners to prosecute such law-breakers, informing them of those rum-sellers and wishing to have them prosecuted, and they wrote him back telling him they would do so, if he, Peter Gavin, would furnish the money to cover the costs of the same. Now, Mr. Editor, it seems that there is just where the trouble comes in. There have been three or four men appointed by the Government at a salary of from three to five hundred dollars a year to grant licenses to vendors, and inspect the liquor sold by those vendors, and prosecute all illicit rum-sellers in Prince County; and, when any person informs any of these officials that such and such a person is selling liquor in open violation of the law, and will produce good evidence, and wishes to have said rum-sellers prosecuted, they will tell you they cannot without the informer advancing sufficient money to cover the costs of the prosecution.
Now, what is all this Government money for, if not for the purpose of bringing all those mean, low-lived individuals, who are daily violating the law by selling those poisonous drugs in the name of whiskey, gin and rum, to justice.
Perseverance Division of Brae, Lot 9, is doing very well notwithstanding the temptation held out to young men by those daily violators of the law (the rum sellers). A few of our young members have violated their pledge, but surely those vendors of the poisonous stuff who are holding out the temptation will for their crime be answerable.
