APEC Sponsored Vessel Loads Cargo For Goose Bay

The new steamship service between Maritime Provinces' ports and the North brought the M.V. Fauvette into Charlottetown Tuesday for the second time. She loaded miscellaneous cargo destined for Goose Bay.

Dr. Frank MacKinnon, president of the Atlantic Provinces Economic Council, met the ship and welcomed her skipper, Captain Leonard, on her second visit to the island. The shipping service to the North has been fostered by APEC as one of its projects aimed at increasing market for Maritime produced goods, and products.

There was less cargo from Charlottetown this trip, but the load from Halifax was greater than last time by over 100 tons.

The Fauvette will continue to come to Charlottetown through-out the shipping season.

"We look forward," said Dr. MacKinnon, "to shipping our choice island agricultural products in the fall. We hope our growers and shippers will take full advantage of this new service into the big and growing market up North."

Priest Passes In Hospital

Rev. Andrew Leo Herrell died at the Charlottetown Hospital on August 5, 1958.

Born at Hope River, he was the son of John Herrell and Rose Trainor. He received his early education at St. Patrick's Road and New Glasgow. He attended Prince of Wales College and St. Dunstan's University for six years and made his theological studies at Laval from 1910 to 1914.

He was ordained priest at Kelly's Cross by Archbishop Stagni, then Apostolic Delegate to Canada, on June 14, 1914.

Another frigate scheduled to make the visit to Charlottetown, HMCS Lanark had to remain in Halifax because of mechanical difficulties.

Among the officers on board Fort Erie is Lt. J. J. Mahar, university naval training officer of Charlottetown.
