**Eight - year - Old Shirley Smallwood Dies From Injuries**

A charge of manslaughter, arising from the death of Shirley Smallwood, eight-year-old Bunbury school girl, from multiple injuries suffered when she was struck by an automobile driven by Mr. William Phillips of Charlottetown, was laid against the car driver yesterday. Phillips was released on bail of \$2,000 after Magistrate G. J. Tweedy set May 25 as date of the preliminary hearing of the case.

An inquest into the little girl's death opened in Charlottetown yesterday. It was adjourned until Saturday after a coroner's jury viewed the body and visited the scene of the fatal occurrence.

Shirley Smallwood, only daughter of Mr. and Mrs. William Smallwood of Bunbury, died in the Prince Edward Island Hospital early yesterday after she had lain unconscious 15 hours from the time she was struck by Phillips' car on the road near Bunbury school-yard.

Dr. I. J. Yeo was the coroner. The jury was composed of Messrs. F. J. MacDonald (foreman), R. H. McNeill, Victor Linn, Murdoch Ross, Sam Vail, J. Peter MacDonald and Harry James.

**Quebec Rover Scout Awarded Bronze Cross**

(C.P. By Guardian's Special Wire) OTTAWA, May 19.—Rover Scout Charles Maitais, 17, of the French Catholic Scout Association, La Tuque, Que., was today awarded the bronze cross by Lord Tweedsmuir a Chief Scout for Canada.

This seldom given medal was awarded for the rescue of a baby brother when the Maitais home was destroyed by fire on the night of April 4. After the order members of the family had escaped it was discovered that the baby was still in the house. Rover Maitais plunged into the flaming house, found the child and with it in his arms leaped from a window.

He was gravely burned about the head and body and for a time little hope was held for his recovery. He is still in hospital at La Tuque.

**Canadian Press News Service To Start In June**

(C. P. By Guardian's Special Wire) TORONTO, May 19.—The Radio Committee of The Canadian Press today approved the contract with the land-telegram companies providing for the coast-to-coast distribution of Canadian Press radio news bulletins to broadcasting stations. The service is expected to start early in June.

The Canadian Press will provide free of charge at Toronto three bulletins daily—morning, noon and late afternoon—which will be transmitted to broadcasting studios at nominal charge. The late evening Canadian Press summary of the day's news over the Canadian Radio Commission network will continue.

The bulletins, prepared at the head office of the Canadian Press, will cover the highlights of world and domestic news up to the minute.

**Creosoted Timber Purchases Probed**

TORONTO, May 19.—Premier Hepburn today said cheques for creosoted timber purchases in northern Ontario had been held up pending a study of the need of this material in building bridges. **CANADA'S U.S. TRADE IN APRIL**

OTTAWA, May 19.—The United States was Canada's best customer in April by taking domestic exports worth \$31,554,000, an increase of almost 24 per cent compared with \$25,455,395 in April, 1935, the Dominion Bureau of Statistics reported today.

At the same time the United Kingdom was in second place taking goods valued at \$15,206,000, an increase of 11 per cent in comparison with \$12,412,910 in April last year.

Canada's total domestic exports were worth \$57,423,830, an increase of \$10,109,970 or more than 21 per cent over April 1935.

**SEeks FEDERAL AID FOR ALTA.**

**Social Credit Premier Interviews Prime Minister.**

OTTAWA, May 19.—Finance, relief, public works and tourist traffic were discussed today between Premier William Aberhart of Alberta and Prime Minister Mackenzie King, but neither would disclose the details of their conference which will be continued tomorrow or Thursday.

Head of the world's only Social Credit Government, Mr. Aberhart is understood to be in Ottawa primarily to request again the Federal treasury to assist him in converting provincial debts at lower interest and otherwise putting his financial house in order, paving the way for initiation of Social Credit dividend payments.

Early in March Mr. Aberhart sought Federal treasury assistance in meeting a provincial bond maturity due April 1. About the same time he announced his intention of carrying out currency conversion of some \$160,000,000 in provincial debt at a lower interest rate.

When Mr. Dunning made it plain that he would not authorize a Federal loan to Alberta unless the Social Government would submit to future control of its borrowings by a loan council, Mr. Aberhart refused these terms and his April 1 maturity was defaulted.

What new plan Mr. Aberhart may have to lay before the Federal Government has not been made public.

Mr. Samuel McNeill, Nine Mile Creek, was the next speaker. To have the ferry boat closed in would be a step in the right direction, he thought. If it was not closed in it would be better to take it off in the fall. He was not in favor of free fare but would like to see it reduced by half. It costs only about one third as much to operate the new boat as it did the old "Hillsboro", he claimed.

Mr. Mitchell explained that he did not mean free fare for everyone, just for the farmers who are hauling their products to market.

Regarding the bridge question Mr. Mitchell said he understood Premier Campbell must have been given some encouragement for the project when he was in Ottawa. He had been told, Mr. Mitchell said, to incorporate that in his resolution. "Don't let us be cheap like our government," he continued. "They go up to Ottawa and ask for a few thousands and are laughed at. British Columbia asks for six millions and gets it. I've borrowed ten millions tomorrow and I would have it back in ten years. The speaker then went on to explain how by the expenditure of many millions of dollars Florida became one of the greatest tourist centres on the North American continent.

"If governments spent money the right way, they would get it back," he said, "instead of going in debt trying to get the money back by taxes."

"We must get away from the idea of appointing lawyers as premiers," Mr. Mitchell stated. "They are in it the first four years for honor and the next four years they are looking for a judgeship."

In Charlottetown the members will promise almost anything but will give nothing. Politics was a queer thing anyhow but there has been too much of it, he thought.

So far as the tourist traffic was concerned he felt the money could be spent to better advantage on the roads but since the money had been voted for a park it would not be used for anything else so "if they are going to give it let us fight for it in this neighborhood. **TEXT OF RESOLUTION**

BE IT RESOLVED That we, the electors in the Second District of Queens, respectfully request our Provincial Government to have the upper dock and front of the Rocky Point ferry (Fairview) covered in out as far as the guard chains on each side of the ferry boat so as to stop the draft and cold from the horses and men during the cold windy days in the fall and spring and perhaps save a farmer from losing a valuable horse or his own life.

AND WHEREAS if these proposed Brighton-Rocky Point bridge projects be started we will still be compelled to use the ferry boat for several years to get our products to Charlottetown, therefore we feel it is an imposition on our farmers to expect them to pay such high ferry charges or tax for the privilege of taking their products to market, therefore we are asking our government to give us a free fare that we may be placed on the same basis as farmers on the other side of the river.

AND WHEREAS as the ferry boat was not placed on the Rocky Point service for the purpose of making money for the government but was placed there as an accommodation for the farmers to get their products to market and as no provision has been made for the late trip of the ferry on Saturday nights during the summer months, that we could bring our families to town to do our weekly shopping or take
