## T.C. Douglas Will Speak To UN Club At PWC Sunday

National Leader T.C. Douglas of the New Democratic party will speak to the United Nations club here Sunday night at 8:30 in the library at Montgomery Hall. It was learned last night from Tommy Dunphy, provincial party organizer and candidate in Kings County.

The PWC section of the UN club was organized several weeks ago and Mr. Douglas will be the second top-level federal political figure to have heard Last week the members heard and met Hon. Howard Green, secretary of state for external affairs.

Mr. Douglas who will arrive at the airport at 6:30 Sunday evening, has a busy schedule facing him.

He speaks in Moreside Community Hall on Monday at 1:30 p.m. to the South Kings County students at 3:15 and in the United Church hall at 3:45.

He will be in Summerside at 5:30 to address a general public meeting.

J.B. Murley, manager of the Charlottetown Branch of the Unemployment Insurance Commission, announced Friday morning that an investigation and enforcement branch will be opened at Charlottetown on April 1.

The announcement was occasioned by the appearance of a violator of the Unemployment Insurance Act, before Magistrate James B. Johnston in Queens County magistrate's court, Thursday and Friday.

### Du Pont Ordered To Sell GM Shares

CHICAGO (AP) — The Du Pont company and Christiana Securities Corporation were ordered here by the U.S. District Court to divest themselves of more than 63,000,000 shares of General Motors Corporation stock within the next three years.

The order, as Judge Walter J. La Bay, appeared to agree with proposals by Du Pont lawyers with respect to divestiture steps to be taken.

La Bay, putting into effect a Supreme Court ruling which sets his own finding of June 3, 1957, held that retention of General Motors stock by the Du Pont company and members of the Du Pont family does violate the Clayton Anti-Trust Act.

## Second Man Is Committed To Trial For Break Into Club

A second person, Francis Vernon Donnelly, Charlottetown has been committed to the next session of the Supreme Court for trial on a charge of breaking a door entering, by Magistrate A. J. Haslam in city police court.

Donnelly, not represented by counsel is charged with breaking into and entering into the Ballway Employees Club, 130 Richmond Street, Charlottetown, on the morning of Feb. 28, in his night.

**FOUR WITNESSES**

The preliminary hearing of the case was completed yesterday with the Crown calling four witnesses to the stand. The defence called one and neither did he call any witnesses in his own defence.

The case for the prosecution was conducted by Deputy A.T. Torrey-General J. Arthur McGillan.

Pleading guilty to speeding at 53 m.p.h. north on Great George Street, Donald Keith Brown, Long River, was fined \$15 and costs or five days in jail.

Fines of \$5 and costs or two days were meted out to two persons on charges of failing to stop for "stop" signs, and to another for failing to comply with a "yield right-of-way" sign.

For failing to stop for a flashing red traffic light, another accused was given a similar penalty, as was another for parking in a metered zone when the meter did not show time purchased. In this last case the fine was imposed without costs.

A lone drunk and incapable was given a 30-day suspended sentence.

The meteorological station at the Charlottetown Experimental Farm reports that the month of February this year was somewhat colder than the same month last year.

The average temperature for the month was 11.6 degrees and for the month last year 13.8 degrees. The 20-year average temperature for the month of February is 13.4 degrees.

(Continued from page 1) getting from the press 1300 duties that its high position would warrant.

"I suggest there is something wanting in the press in this province—two men looking out separate windows is quite different than two men looking out the same window."

The same applies in other provinces with one owner having two windows in newspaper.

**PROGRAMS QUESTIONED**

Mr. Farmer suggested that a provision should be made for prosecution in cases of "immoral or questionable" television programming.

"I don't know what can be done," he said, "but from time to time there are television shows that are not proper for the sanctity of homes in this province. In many instances the family is gathered, children are around, and these programs are not proper. We shouldn't be asked to accept offense in our own homes."

Mr. Farmer said there are four units concerned with television programs—the producer, the advertiser, the CBC and the local station. I suggest that the provision be made for the prosecution of four of these, that is the Attorney-General would have someone he can lay an information against.

**SPEAKS ON AGRICULTURE**

Speaking briefly on agriculture, Mr. Farmer suggested that "companies to pack our agricultural products here should be discouraged from entering into farm operations—let the packers pack."

He termed the government's resources development program "one of the most progressive moves ever made here as a long time."

Mr. Farmer commended the government for its plans to reform the province's job system. "A prison farm is an excellent idea," he said, "and should be

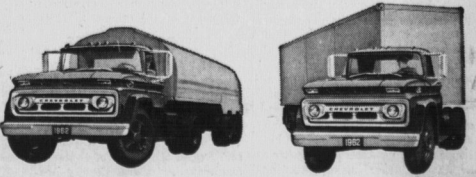
