LETTERS TO THE EDITOR.

"Silk Hats for Beggars"

SIR,—This is a quotation from some editorial remarks of the Patriot of the 7th inst. We poor countrymen who frequent the Market Square in the prosecution of our business, and for which privilege (I) we pay a direct tax to the city, must be dubbed beggars by the Patriot. Surely, Mr. Editor, this is unkind and ungenerous on the part of the editor of that paper, who, himself, hails from the country, and should be the last man to cast a slur on the farmer and others from the country.

But, Mr. Editor, we farmers and others from the country have a still more serious complaint to make, and it is this: The utter neglect of our rights and comforts as shown by the civic authorities. Let me cite a case. My wife or daughter leaves home at 6 or 7 o'clock in the morning, and reaches the market, after travelling about ten miles at say 9 o'clock, and then ascends the market stairs and stands at the tables perhaps for four or five hours. There are no toilet or sanitary appointments provided for their convenience and necessities—no apartment to which to retire for a moment for any purpose. Surely, Mr. Editor, this inhuman, and I was going to say savage, state of things must strike your worthy and kind-hearted Mayor, of whom we are all justly proud, as something calling for immediate action. I, perhaps, may have to return to this subject again. Meantime, I trust that enough has been said to direct immediate attention to this much needed reform.

Parnell Retracts.

LONDON, May 7.

In the special commission to-day Mr. Parnell, on taking his place on the witness stand, astonished everybody by saying he wished to withdraw in toto the statement he made in this place on Friday last, as to misleading the House of Commons in regard to secret societies. He added that he had since consulted Hansard's report of the speech in question and he found that it referred to Ribbon Societies. The information he had given the House was accordingly correct. To say this retraction caused a sensation in the court room would be to describe the scene mildly. Surprise deepened into consternation. There was a stir all over the benches and everybody whispered excitedly to his neighbor.

It is asserted that the prosecution purposely deceived and misled Mr. Parnell, by misquoting his speech in Hansard.

Train Wrecked.

MARYSVILLE, Ky., May 7.

A freight train on the Chesapeake and Ohio road which was transferring the famous Libby prison from Richmond to Chicago, was wrecked seven miles east of here yesterday. The remains of the old prison were scattered about, and people flocked to the city all day to secure old bricks and lumber as mementoes. No one was hurt.

Quiet and Doing Well.

MONTREAL, May 7.

The Inspector of the Mounted Police is in town, and says the Indians and Metis are quiet and doing well. He says Gabriel Dumont's influence is gone amongst his own people, who think Riel's military commander compromised his dignity in exhibiting himself in the wild west show and similar menageries.

Cable Contract.

OTTAWA, May 6.

The Halifax-Bermuda cable contract was presented to the Imperial Parliament last evening. The International Cable Company are the contractors. The Company constructs and works the cable for an annual subsidy for twenty years of £8100. The cable will commence working within five months of the approval of the contract by the Commons.

The Royal Society.

OTTAWA, May 7.

The Royal Society visited Government House to-day, accompanied by the Premier and Sir Charles Tupper. Sanford Fleming, on behalf of the Society, presented an address to His Excellency, after which the party were royally entertained. There are no delegates from the Maritime Provinces this year.

A Questionable Story.

FREDERICTON, May 7.

A P. E. Island man named O'Hara enlisted with the Royal School of Infantry on Saturday for a three month's term, but deserted the same day. This morning the picket found O'Hara at the Indian camp, brought him back and locked him in the guard room.

Commercial Union Riddled.

OTTAWA, May 7.

At a banquet at Brantford last night Winan was present and read his Commercial Union essay, after which Robert Henry, a prominent local man, riddled his alleged argument in such a manner as to completely carry the audience, much to the disappointment of the Gothamite.

Lobster Fishing.

OTTAWA, May 7.

A special cable says that Ferguson, replying to a question on behalf of the Government, said that Her Majesty's Government will support British subjects in the lobster fishery on the French Shore of Newfoundland, provided they do not interfere with French treaty rights.

Freedom of the City.

LONDON, May 7.

The Edinburgh Municipal Council, 23 to 15, confirmed the resolution granting the freedom of the city to Parnell.
