

# Speaker Deplores Number of French-Speaking School Students

J. Edmond Arsenault, general secretary of the Thonau student society, speaking at the organization's recent annual meeting, deplored the fact that only 20 per cent of students receiving financial assistance from the group should attend French language institutions, where they would acquire a thorough knowledge of the French language as well as English.

He further stated that of the approximately 400 students assisted since the society's founding, very few have remained in the province, where there is a pressing need for well-trained young people.

During the past year, he reported, 20 students, including boys and 17 girls have received assistance.

# More Blood Donors Sought Urgently Needed

A total of 1,000 blood donors will be urgently needed during the week of August 18th, according to F. A. S. Jones, provincial Red Cross blood donor chairman.

Mr. Jones stated that the demand for blood donors is unusually high during the summer months in both Nova Scotia and P.E.I. hospitals, and that for the first time in the 16 years the existence of this service, emergency clinics have had to be held in Halifax in order to keep up the necessary supply of blood.

The August clinics, which are to be held at eight centres in the province, will be the third in the series of the five Centennial Year Clinics at which the slogan is "Be a Centennial Blood Donor."

It was learned from Mr. Jones that branches of the Royal Canadian Legion at North Ruston, Eldon, Morel, Souris and Cardigan will again be sponsoring these clinics, while the New Glasgow Junior Farmers will be making the arrangements for the clinic that is to be held at that town.

## William Tribute Paid In Island Presbytery

The following is a tribute to the late Rev. George Killen who died Sunday, July 28, 1964. The tribute is from the Presbytery of Prince Edward Island and is signed by the clerk, Rev. T.H.B. Somers.

"Having just finished the reading of the Lesson, a communitarian service in Crapaud commemorating the Centennial of Confederation. Reverend George Killen passed away on Sunday, July 28th, 1964. Born in Scotland, he came to this country in 1841, and in 1842, he received his early education in the local academy, transferring to the United States in early manhood.

His preparation for the Holy Ministry he took his theological training at the Presbyterian Seminary in Glasgow, Scotland, graduating in 1828. Commencing his ministry in the Presbyterian Church in Canada, the following year, he was inducted at Peihau, Louth and Penetowas in the year 1830. He was later elected the Social Credit party to office for many years.

## More Tourists, Staying Longer Says Minister

Hon. J. David Stewart, minister of tourist development, stated yesterday that there were more tourists in Charlottetown this year and they are staying longer.

Mr. Stewart took one day's spot check traffic figures at Wood Islands to illustrate his point.

Mr. Stewart said there were 202 people involved in the check made on August 1st. Of these, 12 per cent left the province the same day, 28 per cent remained in the province more than two days and the remainder, 60 per cent were in the province ranging from five days to three weeks.

Mr. Stewart expressed the opinion there was more camping in the area than last year and expressed the thought from his own observation that there were more visitors from Quebec than Ontario.
