Island Odds and Ends

When racing fans sit in on the first horse-racing card of the local season at the Charlottetown Driving Park near the end of June, they will take note of the large new show building which is rising north of the main grandstand, one of the many improvements made in the past few years. Some of the oldtimers, who can look back thirty or forty years will remember when the whole layout of the exhibition grounds, the buildings, the track, and the accommodations were far different. Yes, there have been changes over the years, but there will be one notable exception, the MacKinnon racing colors will still be there, and Colonel Dan will be teaming his own horses. While his string of three, which includes the good trotters Pet Hanover, and Feather Duster, and the pacer Lassie Lucille, Colonel MacKinnon will continue his association with the racing game, which commenced more than four decades ago.

Easily the dean of the track, both as owned and driver, the Colonel removed any idea that he might be retiring from the game, when he bought the trotter Pet Hanover at the Summerside sale several weeks ago. Since then he has been actively training his new acquisition as well as his other two horses, daily. All three should show up very well in the summer racing summars, according to stable talk. If the record of the MacKinnon stable was erased from the history of Island and Maritime racing, some of the pages would be dull reading, so oft has the MacKinnon entries provided the competition, and the color to make the day's card thrilling and spectacular.

How much is a smile worth? While we all know that a smile has value, most of us would not feel like interpreting such a natural and spontaneous manifestation in terms of dollars and cents. However, "The Management Review" quotes a story indicating that a jury once set an actual monetary value on a smile. The amount was \$20,000.

The story involved a boy who had his face burned and partially paralyzed by a broken live wire. In court the boy's lawyer told him to turn to the jury and smile. The result was pathetic. One side of the boy's face smiled, but the injured side just puckered up in a pained contortion. After deliberating for 12 minutes the jury awarded the boy \$20,000.

That jury recognized that no monetary consideration could compensate for the loss of a smile. Our human relations are influenced more than we ordinarily realize by the simple fact that we can and do smile.

Suggests Doctors Sell Drugs to Addicts

OTTAWA, (CP) — Harold E. Winch, CCF member for Vancouver East, says the illegal narcotics trade could be crippled if addicts obtained drugs from doctors at cost.

"If you take the profit out of the illicit traffic, you will go a long way to wiping it out," Mr. Winch said Tuesday in the Commons during debate on amendments to the narcotic drug act. He supported a change increasing the maximum penalty for narcotic peddlers to 14 from seven years, but said the approach to the addiction problem should be medical, rather than punitive.

Health Minister Martin interrupted at one point to say there is no law against doctors treating patients. The law merely ensured the doctor acted responsibly and honorably. "The people of Canada don't know that," Mr. Winch replied. There had never been an educational program to encourage addicts to go to doctors for treatment.

Assistance Promised If Quebec Undertake Power Development

MONTREAL (CP) — Transport Minister Chevrier said yesterday as much as \$400,000,000 may be spent in the Montreal area if the Quebec government decides to undertake power development in conjunction with work on the St. Lawrence seaway.

Decision on the power development rests with the provincial government, he said, but the time for making it is "growing short." Mr. Chevrier's speech was prepared for delivery at a luncheon of federal and municipal officials following official opening of an Atwater street tunnel under the Lachine canal.

Referring to the seaway, Mr. Chevrier said he hopes for final clearance on power development in the International Rapids section "with a matter of days, almost." The major part of federal government expenditures on the St. Lawrence seaway canals would be in or near Montreal. An estimated 120,000,000 would be spent on navigation works in the Lachine canal section here, and approximately \$30,000,000 at nearby Beauharnois.

If the Quebec government decided on development of 1,200,000 horsepower in conjunction with the seaway expenditures in the area would amount to approximately \$400,000,000. The new 787-foot tunnel under the canal was officially opened by Finance Minister Abbott. The tunnel cost approximately \$6,750,000 and another, opened earlier, cost \$4,500,000. The transport department constructed the tunnels, with the battle designed to keep the British Army off balance, and impede its plans to mount an attack on the Somme River.

Howe Rules Out U.S.-Can. Export Pact

OTTAWA, (CP)—Trade Minister Howe yesterday ruled out suggestions of agreement between Canada and the United States on export grain prices.

"Canada has its sales policy and the United States has a sales policy made in that country," Mr. Howe said in the Commons. "I hardly think that the idea of forming a combine against the rest of the world would be popular in either country, and certainly not in other countries."

Mr. Howe had been asked by Hazen Argue (CCP — Assiniboia) whether Canada and the United States have agreed to co-operate in their policies on grain exports.

U. S. Tennis Star Wins Matches

MANCHESTER, (AP)—Maureen Connolly flew in Tuesday from France for her first taste of British tennis competition and her first work on grass courts this year, and hardly gave the spectators time to see her in winning two matches in the Northern Lawn Tennis championships.

The 19-year-old San Diego, Calif. star who will defend her Wimbledon title starting June 21, needed only 19 minutes to dispose of Mrs. L. G. Walter of Belgium 6-0, 6-0.

She didn't take much more time in beating Britain's Pat Hird 6-1, 6-3.

Ken Rosewall, Australia's second-ranked player, also won two matches to reach the fourth round of men's singles. After blanking Robert Coope of Britain 6-0, 6-0, Rosewall had a tough fight against 19-year-old Alan Mills of Britain, winning 7-5, 7-5.

Rex Hartwig of Australia beat Andre Kalman, Britain, 6-0, 6-1 in the third round.
