The New Ministry.

SIR JOHN THOMPSON has exhibited a great deal of skill and care in the formation of his Cabinet. His retention of Sir John Abbott and Hon. Frank Smith as ministers without whose will no measure in respect to difficult questions of policy and administration, the advice and assistance of two men of unquestioned ability and large experience. His transfer of the Hon. McKENZIE BOWELL to the new and important position of Minister of Trade and Commerce will secure for those great interests the attention of one who has won, in the course of a long, unbroken political career, the confidence of the country at large—one who, as Minister of Customs, received a special training for the work to which he has now been called. The fact that Mr. Bowell remains in the Government and that Mr. Clark Wallace has accepted a seat in the cabinet and is one of the Comptrollers of Customs and Inland Revenue is a strong evidence that Sir John Thompson does not contemplate an attack upon Protestant interests. As Minister of Agriculture, Ex-Governor Angers will be more interesting in the eyes of our farmers than he was, even when driving from office the wicked Mercierites. He certainly has a wide field in which to display political skill and ability as well as large and generous sympathy with our farmers. We trust that he will prove to be a worthy successor of Hon. Mr. Carling. Mr. Curran, the brilliant Irish representative of the Irishmen of the great city of Montreal, is Solicitor General. For the most part, Sir John Thompson has retained the old Ministers in the old offices, with which they are familiar, and given the new positions to the new men. In this he has shown his wisdom.

The City Court.

It appears that judges sometimes differ—as well as lawyers and doctors. The decision of Judge Alley in the Joy case does not, of course, affect the position of Mr. Fitzgerald as Judge of the City Court. Nevertheless Judge Alley has pointed out that Mr. Fitzgerald occupies an anomalous position. The City Incorporation Amendment Act provides that "The person who shall be appointed Stipendiary Magistrate for the City shall not fill any other office." A provision in the same Act that the Stipendiary Magistrate shall hold a court for the recovery of small debts was, subsequently, by inadvertence, we presume,—repealed by the Act which provides that "there shall be in said City a Court of Record to be called 'the City Court,' over which one Judge shall preside." Further, it is claimed that the appointment of all Judges lies with the Dominion Government. Under these circumstances it seems to be necessary (1) that the Local Legislature should, by special enactment, remove the disqualification of the Stipendiary Magistrate for any other office; and (2) that Mr. Fitzgerald shall receive his appointment as Judge of the City Court from the Dominion Government. There ought to be no difficulty about either of these points. We need not enlarge upon the fitness of Mr. Fitzgerald for the position, or upon the importance of maintaining the City Court. The City Court is resented to by most of our citizens who have to sue, and confidence in Mr. Fitzgerald's ability, as a judge is very general. His long and honorable career as Stipendiary Magistrate, and the satisfaction which he has given in the discharge of his duties, constitute a strong claim upon the prompt consideration of the Provincial Legislature and the Dominion Government.

Fresh Breezes.

THE GLOBE of Chicago—a quarterly review of literature, society, religion, art and politics, contains an article entitled "Fresh Breezes from Behring Sea," which is remarkable for vituperative energy as well as for the mass of solid truth which it contains. The writer refers particularly to General Butler's article on the Behring Sea controversy, in the North American Review. He declares that "General Butler, like all his tribe from Samuel Adams to this day, writes without any regard for the truth, without any desire to get at or state the bottom facts in the case; indeed, with a brazen, unconfessed purpose to evade the truth, to put a false and plausible assumption in the place of truth; and then proceeding on the assumption that England is all in the wrong in this matter, as in every other else, this famous one might almost say infamous—old Yankee proceeds to show how easy it would be for the United States to put the British Empire in their pocket and wipe the gutters of Boston with the rest of the universe." He then denounces "the moral obliquity of New England during the last two hundred years until now her representative sons and daughters will put falsehood for truth, darkness for light, vice for virtue, and smile at their smartness with a sort of squint-eyed shrewdness, dreaming all the while that neither God nor man sees or notices these things any more."

A Correction. Sir,—I notice in last evening's EXAMINER a communication signed "Samaritan," in reference to an article which the writer says appeared in the Morning Guardian. The facts of the case are these: The man referred to fell down the steps leading to the basement of Zion Church, not during the prayer meeting, as stated in the article in your paper, but a considerable time after the meeting had been dismissed. not usually claimed or refused in ocean waters? Second, to what extent is the Government of the United States refusing, rights in the Behring Sea that England did not claim and exercise while Alaska was a Russian possession, and that Russia admitted and did not refuse? The prediction is ventured, that the arbitrating powers will be convinced, first, that the United States have no other rights in the waters of the seas than are usually claimed and granted to other nations; second, that as the right to fish in the open seas is a right claimed by and granted to all nations and men, the arbitrating powers will concede that as Behring Sea is part of the waters of the common oceans of the world, the English and British-Canadian, in common with Yankees, Indians, Esquimaux and Chinamen, have a right to catch tadpoles and seals in Behring Sea, if they are so inclined and if they find the fishery profitable. "Instead of going into this phase of the question, General Butler settles it by one swoop of his august hand, as follows: 'All claims to the lands and waters on this continent have been obtained through the right of discovery and occupation.' This is a singularly stupid, disjointed, vulnerable, and lying statement. It was meant to be very wise and very knavish, or both; but, unfortunately, knavery and wisdom do not go together, even in modern politics and modern literature. It would be nearer the truth to say that all claims to the lands and waters on this continent have been obtained through wholesale robbery and murder. "If you choose to squint at the "eternal principles of humanity"—and conclude, after all, that they only mean all the red men, black men, and all the silver spoons you can grab and mortgage and sell, in order to put North American Review money into your rascally pocket, you can write all the articles you please without 'honor or honor in them, but you will be apt to find arbitrative Nemesis somewhere, that will knock your Yankee notions into everlasting contempt. As regards the present difficulty between England and the United States, nobody questions the 'claims to the lands and waters in this continent,' and therefore the general's bombast is as wide of the mark as the Yankee's unprincipled statement of fundamental principles is always sure to be. These two lies hold the key to the general's article, and it is worth while to lay them out and bury them as they deserve. If they have any meaning or value in the present case, they mean by implication, at least, that all the lands and waters of this continent belong to the Yankee and his heirs. But by far the greater part of the lands and waters of this continent are still in the unrequited possession of the Spanish, the Brazilian-Spanish, and the English, and the true inwardness of the General's grotesque claim would only be admitted by a man intoxicated with bad morality or bad whiskey. It is to be feared that General Butler has long been suffering from the double malady." The writer proceeds to argue the question in detail, and says to the General: "You may dodge or fool the editor of the North American Review—that is an easy task. You may, perhaps, purchase him with a tip—Carnegie-like—and get your windy trash into its pages, and put money in all your pockets; but you cannot dodge the editor of the Globe or escape the damnation of hell."

Hon. J. H. Haggart, Minister of Railways and Canals. Hon. John Costigan, Secretary of State. Hon. A. R. Angers, Minister of Agriculture. Hon. Sir A. P. Caron, Postmaster General. Hon. Chas. F. Tupper, Minister Marine and Fisheries. Hon. J. J. Curran, Solicitor General. Hon. Clark Wallace, and Hon. Colonel Tisdale, Comptrollers of Customs and Inland Revenue. Sir John Abbott and Hon. Frank Smith, Ministers without Portfolio. Hon. J. C. Patterson, Minister of Militia & Defence. Hon. W. B. Ives, President of the Council. Hon. Thos. M. Daley, Minister of the Interior.

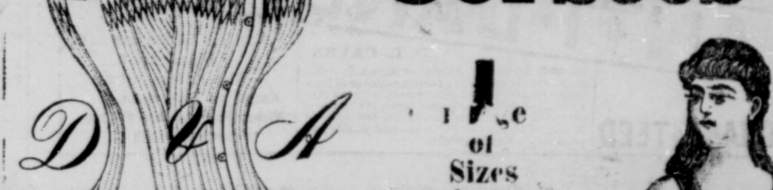
