**GRONCHI VISITS POPE**  
VATICAN CITY (AP)—Italy and the Vatican marshalled colorful pageantry Tuesday for a formal meeting between their heads of state—President Giovanni Gronchi and the Pope. It was Gronchi's first visit to the Pope since the president was elected last April. The call was in keeping with a treaty signed in 1929 recognizing the fully independent status of the 109-acre Holy See in Italy.

## Prompt Action Checks Fire; Youth Remanded

Prompt action on the part of LeRoy Creamer, an attendant at Nelson's Service Station at the east end of Grafton Street, was responsible for preventing a fire from starting at the gas tanks about 10.00 p.m. Monday night. Mr. Creamer had been doing some work on his own car and had shut off the lights preparatory to leaving when he noticed a flame come up to the gas pumps, take the hose from the pump and spill some gas on the snow. As he watched from the darkened building, Creamer told police he saw the young man retire a short distance from the pump and drop a lighted match into the gasoline. The service station attendant bolted out the door and started in pursuit. After a short chase brought him back to the service station from where he phoned the City Police. The fire did not spread on the snow covered ground and was quickly extinguished before it could do any damage. Yesterday morning a 17-year-old boy appeared before Magistrate Martin in City Police Court and was remanded on \$50.00 bail. Charged with disorderly conduct, he will appear again this morning.

## Jury Finds Verdict Of Accidental Death

A verdict of "accidental death" was returned in the death of William Vincent DeCoste by a coroner's jury at the inquest held last night at City Hall. The jury added that death occurred under such circumstances as not to suggest negligence on the part of anyone. The four-year old child was killed on the afternoon of Nov. 30. The inquest was presided at by Coroner L. E. Prowse represented by Mr. J. P. Nicholson. Jurors were Messrs. Frank MacDonald (foreman), Reginald MacNeil, Bernard Gallant, James H. Morris, Neil MacFadyen, James R. Flannigan, Ernest Gallant. The report of the provincial pathologist, Dr. J. H. Shaw, was read by the coroner. It showed that death was caused by external force applied to the skull from opposite directions, causing extensive damage to the brain tissue. Constable Preston Hillier told of receiving a call while in the patrol car about 1.40 p.m. on November 30. He proceeded to Bayfield Street immediately where he found a young child lying on the street in front of the house. The child appeared to be badly injured. Const. Hillier sent a call by radio to the Police Station requesting an ambulance at the same time asked to have the Charlottetown Hospital alerted for a serious accident case. In company with Deputy Chief Sterns Webster he questioned several people who gathered at the scene but was unable to find anyone who had seen the child receiving the injuries.

Charles Coughlin, an employee of the Charlottetown Street Department, said that he was engaged in cleaning a catch basin at the corner of Queen and Bayfield Streets when he happened to look up the street and saw a child lying not far from the curb with two other children near him. Mr. Coughlin ran to the child, took his coat off and put it under the child's head. He asked some women for a pair of scissors with which to cut the strap holding the youngsters up. The witness did not see any car pass, but while he was at work said he was aware that a vehicle had passed by him.
