give evidence to the tribunal as soon as its appointment was announced, and added: "I have come to my decision because the way my name and private affairs have been handled about my resignation as a member of the government impossible."

Had No Differences

Thomas said he had no differences with his colleagues on matters of policy but after the recent events he considered that "instead of being a source of strength to your cabinet I shall merely be a drag on it, not in a position to pull my full weight."

"I ought in fairness to all parties and the House of Commons to emphasize I feel no resentment at this demand for full and impartial investigation, inasmuch as the absolute integrity of public life in this country is involved."

The letter concluded: "It is well known that I had no political differences with my colleagues or with the policy of the National Government. I am fully conscious of the great and difficult problems—changing almost hourly—which have to be faced by the cabinet and in coming to this decision which means so much to me I can only wish you and all of my late colleagues God-speed in leading the nation out of its present difficulty."

Yours, very sincerely, "J. H. Thomas."

Prime Minister's Reply

The Prime Minister replied: "My dear Jim: "You have acted as I should have done in your place. "I accept your resignation with deep regret, which I know will be shared by all my colleagues. "The loyal support you have given through the strenuous year to the National Government will always be remembered by those who worked with you. "With all good wishes, I am, "Sincerely yours, "Stanley Baldwin."

Thomas was the third minister to resign since Mr. Baldwin re-organized the government after the general election last year. Sir Samuel Hoare, Foreign Secretary, resigned as a result of the Hoare-Laval proposals for the settlement of the Italo-Ethiopian dispute, and Lord Eustace Percy, Minister without portfolio, the so-called "minister of thought," resigned because he had too little to do.

The oft-reported cabinet shake-up was believed to have been hastened by Thomas' departure. A second vacancy in the ministry is expected shortly through the retirement of Viscount Monsell, First Lord of the Admiralty. It had been assumed that Sir Samuel Hoare would then re-enter the cabinet as First Lord, but it is now being suggested that Sir Samuel may become Secretary for the Dominions, with Malcolm MacDonald going to the Colonial Office. In this case, William Ormsby Gore, First Commissioner of Works, would likely be chosen for the Admiralty, although in some quarters Ormsby-Gore was regarded as a likely choice for the Colonial Office.

They found a number in the City, which are kept by business concerns for protection purposes and some in homes which are souvenirs, which have not been registered. They pointed out that it is necessary according to the law to register all firearms for whatever purpose they are kept, if they can be concealed on the person.

Personals

Speculation Rife

Political observers, speculating upon Sir Samuel Hoare's possible return to the cabinet, assert Italy's success in the Ethiopian adventure has proved the former Foreign Secretary "a far-sighted prophet."

Prime Minister Baldwin went to Chequers, his official country residence, before the resignation was announced. He is expected to lay plans to bolster the cabinet in order to continue in office at least until after the coronation next year.

The downfall of Thomas in a sense is due to the fact that Lloyds, the great insurance concern, accepts risks against anything. That, according to testimony before the tribunal, enabled two friends of Thomas to make \$96,500 by gambling that the government would raise the income and tea taxes.

Testimony was given that Thomas won money by "insuring" against the calling of a general election in 1935. It also came out that Alfred Bates, a friend of Thomas, had promised to pay the minister \$100,000 for his autobiography to be written after his retirement. Most of this sum was paid in advance, going for the purchase of a house at Ferring-on-Sea which Mrs. Thomas was "very keen on."

Emphatic Denial

Appearing before the tribunal, Thomas emphatically denied he had disclosed any of the budget secrets. His conversation on budget day with Sir Alfred Butt, wealthy merchant and one of those who profited by the budget insurance, was about horse-racing, Thomas testified.

The minister's withdrawal from the cabinet brings about further disintegration in the "national" character of the government, inasmuch as he was one of the four important members of the Labor government who bolted Labor ranks in 1931 to go into Ramsay MacDonald's coalition ministry.

Of the four, only MacDonald now remains. He is Lord President of the Council. Philip Snowden, now Lord Snowden, quit in 1932 when the general tariff policy of the government was inaugurated, and Lord Sankey, the Lord Chancellor, was left out in the reshuffle that followed the election last year.

Important Discoveries In Royal Society

(By Guy E. Rhoades, Canadian Press Staff Writer) OTTAWA, May 22—Dr. E. Gordon Young of Halifax and W. Robert Inman of Summerside, Dalhousie University Research workers, reported discovery of the composition of salmon egg casing to the Royal Society of Canada today. They said that the casing has now been shown to belong to the class of substances known as soleroproteins and to be similar in certain ways but not identical with the substances of hair, tortoise shell and feathers.

beat and kicked her. McCrea said Dean admitted shooting Poole, who had been lured to the lonely spot by a ruse, as Poole knelt before his captors.

"I shot him; I thought it was my job, according to our discussion," McCrea said Dean told him. Davs and Dean are employees of the Detroit Public Lighting Commission. Most of the others held are factory workers.

Navarre said 34 other members of the organization were being sought as having attended a meeting of the "Wolverine Republican League" at which the abduction of Poole was planned. Headquarters of the league, which is not connected with the republican party, were raided today and a dozen firearms, a large quantity of ammunition, two daggers, and several black robes and hoods, bearing a skull and crossbones insignia, were confiscated.

"As the story was told me by the men under arrest," Navarre said, "a meeting of some 50 members of the society was called by Davis the night of May 12. Prior to the meeting Herrhell Gill and Lowell Bushing, relatives of Poole's wife, told Davis Poole had kicked and beaten his wife."

Mrs. Poole, to whom a daughter was born the day after Poole was slain, denied that Poole had ever beaten or kicked her. Navarre said some of the men held had expressed fear that their statements would lead to reprisals by other members of the black legion, which they told him had branches throughout the country. They refused to name other cities in which the organization is active, saying its motto was "secretary always," he said.

Last Respects Paid Victoria Editor

VICTORIA, May 22—The funeral of B. C. Nicholas was held today while citizens of Victoria paid last respects to their "counsellor-at-large." Tributes from over Canada continued to pour in as the editor of the Victoria Times was borne to his rest by the men who had been trained by him in the newspaper profession.

Mr. Nicholas died from a cardiac attack on Tuesday. The Government of Canada was represented by Brigadier D. J. MacDonald, officer commanding military district no. 11. Premier T. D. Pattullo represented the British Columbia Government. Hon. S. F. Tolmie, former British Columbia Premier, also attended.

Still Unsolved

OTTAWA, May 22—Premier William Abernethy returned with his ministers to Alberta tonight with his main problem—financial relations with the Dominion treasury—still unsolved. Four days of conferences with Prime Minister Mackenzie King and his ministers brought basis for agreement on relief and kindred matters but no decision as to the possibility of compromise over the question of federal loans or guarantees to the provinces.

Sudden Death Of Right Rev. Thos. P. Curran

HALIFAX, May 22.—Right Rev. Thomas P. Curran, administrator of the Catholic Archdiocese of Halifax, died shortly after noon today in the Halifax Infirmary.

Monsignor Curran, upon the death of Archbishop Thomas O'Donnell last January, became administrator of the archdiocese by the vote of the Diocesan Consultors, a group of eight priests. The archdiocese includes the Maritime Provinces and Bermuda, over which he was acting head.

Death came suddenly to the 42-year old leader who had been in hospital only for a short time. He died following an operation for appendicitis.

GRADUATE OF HOLY HEART SEMINARY

Monsignor Curran graduated from Holy Heart Seminary in 1915 and entered the Catholic University of America in Washington where he took a post graduate course. He was ordained into the priesthood by the late Archbishop McCarthy. He became a curate at St. Agnes Church, Halifax, but remained there only a brief time for he answered the call to the battlefield and served as chaplain in France until the armistice in 1918.

APPOINTED TO ST PATRICK'S PARISH

Following his return from France, unscathed, Father Curran was appointed to St. Patrick's Parish in 1919, under the late Monsignor Gerald Murphy. In the same year, his ability in leadership and administration drew recognition when he was appointed.

GIRL GUIDES COUNCIL IN CONFERENCE

Membership Of Organization In 42 Countries Totals 1,300,000. (C.P. By Guardian's Special Wire) EDMONTON, May 22—Mrs. Alan Morkill, provincial commissioner of British Columbia, and Mrs. E. P. Borden, division commissioner of the Crow's Nest Pass, Alberta, have been appointed official delegates to the ninth world conference of Girl Guides to be held in Sweden in June.

Announcement of their appointment was made today when the annual report was presented to Elsie A. Riepert, general secretary, before the 25th annual meeting and conference of the Canadian Council of Girl Guides Association.

The report announced the worldwide sisterhood of guiding established in 42 countries had a membership of more than 1,300,000 with Canada ranking fourth in membership. There are five branches through which guiding reaches girls of all ages in Canada.

Throughout the Dominion there are nine provincial councils and 401 local associations with approximately 1,870 adults who help supervise and promote guiding in their respective areas. Saskatchewan, Nova Scotia showed the largest increase in the number of local associations for the year.

The report announced Lady Tweedsmuir, wife of Canada's Governor General, had accepted the office of honorary president of the Canadian council and that the tour of the chiefs, Lord and Lady Baden-Powell last year was a great benefit to the movement, bringing renewed activity and encouragement across the Dominion.

Australia Opens Markets To Britain

(C.P. By Guardian's Special Wire) LONDON, May 22—(C.P. Cable) —Earle Page, deputy prime minister and commerce minister of Australia, in a statement issued here today, said that the Commonwealth Government's new tariff proposals would provide a new field for British exports worth approximately \$3,000,000 (about \$15,000,000) annually.

(In Canberra, Sir Henry Gullett, assistant minister for trade, announced details of the new proposals to the House of Representatives. They provide for increases in tariffs and licensing system for foreign goods.) Concerning licensing of imported automobiles, Page's statement said "The Commonwealth government has decided that the time has come when it is desirable to establish motor chassis manufacture in Australia."

Study Policies

OTTAWA, May 22—Trade and commerce officials were busy tonight analyzing advices from Canberra of the new trade policies proposed for Australia and designed, apparently, to decrease the imports of automobiles from the North American continent and stimulate manufacturing at home. Officials here were not prepared to comment until they had become fully seized with the significance of the proposed tariff changes. Canada does a large business exporting automobiles and chassis to Australia but it was announced in

Committed For Trial In Robbery Case

Three Charlottetown men, Cyrene Kelly, Fred Phillips and Alfred Clinton, were committed to the next session of the Supreme Court for trial on charges of robbery with violence when their preliminary hearing concluded before Magistrate D. Edgar Shaw yesterday.

Witnesses examined yesterday included Lionel Vautour, a companion of Jeffery the night of the alleged robbery, James Lawlor and Sergeant Dominic Doyle and Police Constable Cyrus B. Jay of the City Police Force, who arrested the accused shortly after the robbery took place on King Street on the night of May 14.

Lionel Vautour told in his evidence of going to a house on King Street on the night of May 14 in company with Jeffery and two Norwegian sailors. The witness had something to drink and about eleven o'clock, after they had been there about an hour and a half, in company with Jeffery and two girls, he went to a cafe where they had something to eat. Before they left Jeffery charged a ten dollar bill for the witness. Phillips was present at the time. He was in the house when the witness and the others arrived. Clinton and Kelly arrived later.

After the witness and Jeffery and the girls had eaten they returned to the house. About twelve o'clock all the men who were in the house left. The witness went out the back door and the others out the front door. There would be eleven or twelve, he thought. About a minute later a hat after he went outside, the witness went around to the front of the house. He saw Kelly standing up and two others over Jeffery. A moment later the three ran across the street and went into a house. He recognized the three as the accused, the witness said. There was no sign of the other men. Jeffery got up and went over to the witness and the two of them went up to the police station. They told a man who was doing office duty at the station about the robbery and then Jeffery left and went to the Mounted Police. When he came back two of the accused had been arrested. Jeffery pointed out one, Clinton, and said, "that's the man that hit me first," the witness said.

James Lawlor, who was doing office duty, told of the arrival of Jeffery on the night of May 14th. He had some blood around his mouth and looked as though he had been drinking a little. When Sergt. Doyle and Constable Jay came back to the station he reported the complaint to them.

Constable Cyrus Jay appeared as a Crown witness, but was not examined by the Crown, but was cross examined by Mr. J. J. Johnston, who appeared for the accused. He told of the arrest of Clinton and Kelly at the cafe on Euston Street, and later in the night of the arrest of Phillips at his boarding house.

Sergt. Doyle was also cross examined by the defense counsel. Mr. Johnston announced that the accused would reserve their defense. Mr. J. O. C. Campbell appeared for the Crown.

The Closing Of Mount Allison

A RESUME OF ACTIVITIES
