Who May Vote:

(2) Provided that every woman residing in the district and being a mother, stepmother, or adoptive mother of a child of school age residing with her and in actual attendance at the school in the district, shall be a qualified voter at all school meetings and shall be eligible for election as a trustee unless she shall be in arrears of school taxes assessed against her.

Mr. Kickham Makes Appeal For Rural Couriers

OTTAWA, June 11 — (Special) — T. J. Kickham, Liberal member for King's, tonight appealed to Postmaster-General Rinfret to increase the pay of rural mail couriers. Mr. Kickham recalled that he had placed a resolution to this effect on the order paper early this session but that it had not yet come up for discussion.

The King's member said his idea was to place all rural mail couriers on the same basis to eliminate the differentials that occurred under the tender system. He would take the present average rate paid rural mail couriers as the basic rate and would increase it by 10 per cent.

This was most reasonable, he said, since Federal civil servants have received salary increases of about 10 per cent as of December 1, 1950. Moreover, he added, there is a slightly better case for increasing the pay of rural mail couriers than of other classes of civil servants in view of the arduous nature of their duties, and long hours.

Mr. Kickham contrasted the insecurity of the rural mail courier with the security of regular civil servants who have sick benefits, superannuation, annual vacations with pay and special leave. He expressed regret that while the Postmaster-General had treated him with invariable courtesy when he made representations on behalf of the couriers, he would grant them no relief from their present situation.

In reply, Mr. Rinfret told Mr. Kickham that to establish an average rate for mail couriers across Canada would bring about "an extraordinary situation." Those above the average would be cut down and those below would be brought up to it. This would be unjust, since rates were fixed by such real factors as climatic conditions, highway conditions; number of boxes, hours of service, and degree of competition.

"If we have an easy contract that can be performed for \$49," Mr. Rinfret said, "and on the other hand we have another contract covering difficult conditions making a tender of \$71 necessary, the person that is contracting at \$71 would be punished very severely, if we were to make some sort of average between those two men. The one having the contract at \$49 would benefit to a great extent for performing those services."

Retirement Of C.N.R. Section Man

Mr. Dan C. MacAulay, Cardigan, one of the best known railroad section men in the eastern part of Prince Edward Island, officially retired this week-end after 41 years of service with the Canadian National Railways. He spent all of his long service on his home section which extends from Montague Junction to St. Theresa's—a distance of about ten miles.

On Friday evening last, a group of railwaymen from the district called at Mr. MacAulay's home and gave him a farewell party. He was presented with a smoking set, and his long service was commended in an address read for the occasion. Mr. MacAulay entered the railway service in 1910. After serving for seven years as an extra man on the section, he was appointed permanently August 1, 1917. Since then he has never missed a day through illness or for other cause from work.

Mr. MacAulay, who is now 65, will continue to work the farm which, with the help of his sons, he has continued to run for most of the years he has been railroading. He began his retirement yesterday by sowing grain with his son, Joe. The railroading tradition in the MacAulay family will still be carried on. Mr. MacAulay's son, Peter, is also a section man with the C.N.R. and is presently working on the Cardigan section.

Montague Town Council Meeting

The regular meeting of the Montague Town Council was held last night in the council room. In the absence of Mayor B. H. Yeo, Councillor Marshall Reynolds presided.

The minutes of the previous meeting were read and approved. Mr. W. R. Connelly, representative of the Irving Oil Co., presented the plans of the proposed eight-foot fence to be erected around the company tanks near the Montague River. He stated that the danger of fire on the beach at the service station tanks. He also said that the erection of the fence would leave a road of approximately eighteen to nineteen feet. It was moved by the council that the fence be erected according to the plans submitted.

After the reading of the accounts, the correspondences was read during which a letter from Summerside was presented stating that the retail business merchants determine the hours of business in that town.

The appointment of a town policeman was referred to the police committee, and two tenders for the position were read.

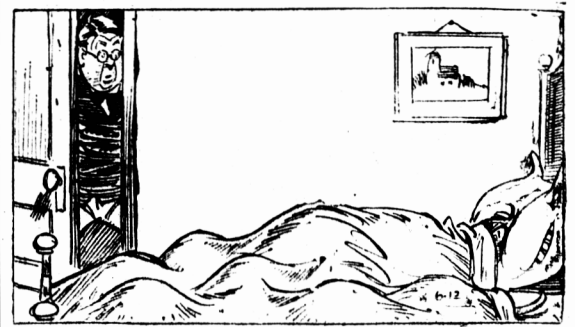
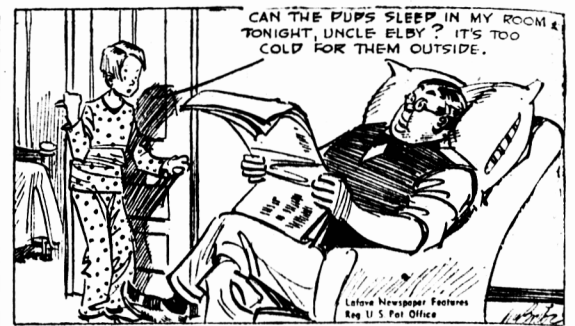
The donor has held the chair in her family for many years and it is hand made from a tree which originally stood on the site of the present Post Office Building in Charlottetown.

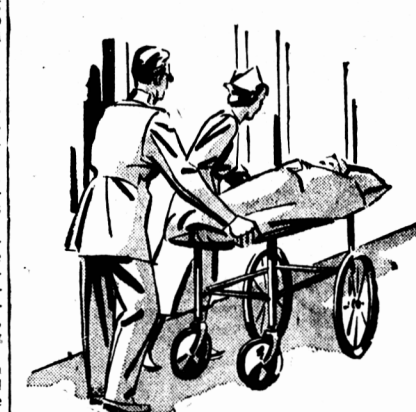

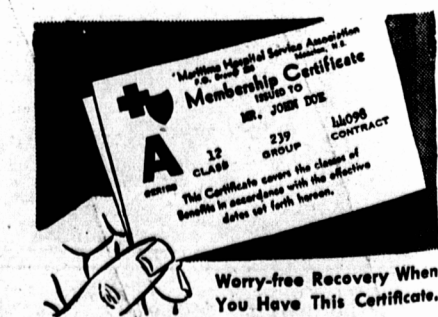
