Canadian-American Relations Are Described As 'Healthy'

Canadian-American relations were fundamentally healthy and the two nations were moving steadily in the right direction to solve common problems and lay the groundwork for future co-operative progress, Honorable Richard B. Wigglesworth, United States Ambassador to Canada, said in Charlottetown last night.

Guest speaker at the Canadian Club's first dinner meeting this season, Mr. Wigglesworth was introduced and thanked by the club president, Frank W. Curtis. In addition to Mr. Wigglesworth and Mr. Curtis, those seated at the head table were His Honor, Lieutenant Governor F. Walter Hyndman and Mrs. Hyndman, Mrs. Wigglesworth, Mrs. Curtis, Premier Walter R. Shaw and Mrs. Shaw, Senator F. Elsie Inman, Mayor Edwin C. Johnstone and Mrs. Johnstone, and Dr. George C. Fisher.

Mrs. Wigglesworth emphasized that the American government makes a point of discussing agricultural surplus disposal projects with competing nations. Concerning wheat sales, for instance, Canadian-American co-operation was close and relations friendly. "In fact, I think it is fair to say that the United States has heeded Canadian expressions of concern and is very careful to keep its wheat disposal program from injuring Canada's dollar markets."

Other areas of international friction in which mutually agreeable solutions were reached included permission to haul certain goods originating in Communist China over American roads while in transit between Vancouver and eastern Canada, despite restrictions applying under the US Trading with the Enemy Act; an understanding regarding American-owned Canadian subsidiaries trading with Communist China; and mutually beneficial agreements respecting the transmission of energy, the development of hydro-electric power and international transportation by air and other means.

ACT WAIVED In defense production, the provisions of the "Buy America Act" had been waived, the Ambassador noted. Canadian contractors and suppliers had therefore the same access to a substantial portion of American defense procurement as their counterparts in the United States. Canadian apprehension concerning American ownership of substantial portions of Canadian industry and Canadian resource

development enterprises was understandable, Mr. Wigglesworth said. However, in his opinion, such uneasiness was a small price to pay for the resultant fantastic growth of the Canadian economy. But with this aspect of economic relations between the two countries the United States government as such had little or no concern except that it expected its Canadian investors to be "good Canadian citizens and constructive members of the Canadian communities in which they settle ..."

Though some Canadian may also be uneasy concerning the unbalanced trade situation that exists between the two nations, the long-term equity investments and short-term loans which give rise to the condition both "reflect in fact confidence in Canada's future and a willingness on the part of Americans to risk their capital in the expectation of profit."

ADMIRABLE ABILITY As a member of the United States Congress for more than 30 years, Mr. Wigglesworth said he had admired the "high level of ability in the Canadian Government." But living with it day after day since his appointment as Ambassador, he was continually impressed with the differences between the two governments. In his judgement failure to understand these fundamental differences had in the past led to "misunderstandings" not only in

F. J. Storey Will Attend Meet Of Services Colleges' Board

OTTAWA—The fifth meeting of the Canadian Service Colleges Advisory Board will be held at the Royal Military College of Canada, Kingston, Ont. Oct. 30-31. The closed sessions will be attended by the Hon. George R. Pearson, C. minister of national defence and provincial representatives including Lt. Col. F.J. Storey of Charlottetown.

The purpose of the board, formed in 1954, is to advise and make recommendations to the minister of national defence on all matters pertaining to the Royal Military College of Canada, Royal Roads, Victoria, B.C., and College Militaire Royal de Saint-Jean, Saint-Jean, Que. Prior to the Second World War a similar board was in existence for RMC and the present Board for the three Canadian Services Colleges is modelled on it.

The board is composed of 12 members representing the provinces with two members for each Ontario and Quebec and one for the other eight provinces, and four members representing the ex-cadet associations of the colleges. The board also includes a number of ex-officio members who are departmental officials. The sessions of the board include a thorough briefing on the academic and military training program at the Canadian Services Colleges and first hand observations of the cadets at work. In addition the commandants will report on the work of their Colleges.

Look into the future, Mr. Rodway referred to the development of quarter turkey roasts. Many homemakers had said the reason they did not eat more turkey was that there was just too much meat. In order to do this, he said, the Agricultural Stabilization Board had initiated a program involving deficiency payments to producers for eggs marketed through egg grading stations or by producer-readers marketing the eggs through retail outlets. REGISTRATION ESSENTIAL Mr. Davey said it was essential that producers should register in order to participate in the program. Egg supplies, he said, to private consumer customers, institutions, cafes, restaurants, hotels and hatcheries did not come under the program. The producer-grader, he said should contact the district office at the poultry division, which in the case of Prince Edward Island is the federal department of agriculture office at Moncton. From that office, Mr. Davey said, that applicant would receive an application for registration and a form that must be used in reporting his weekly statistics. Other forms, such as the forms on which he makes his claim for his credits towards any deficiency payment that may be paid would also be supplied.

Irrespective of the size of the flock the producer can register and if a deficiency payment is made, each person is eligible for payment on grade A large and grade A extra large eggs up to a maximum of 5,000 in one year. If a deficiency payment is made from the period Oct. 1 to Dec. 31, 1959, the maximum will likely be 1,000 dozen A large including A extra large size eggs for that period, Mr. Davey explained. S.L. P.E.I. Government Tackling Potato Marketing Problem

While rumors were current Wednesday in Toronto that the Prince Edward Island government was moving to set up a potato grading plant, in that city as part of its co-operative marketing plans, local producers and dealers are still speculating over the form expected new marketing legislation may take. This week newly-elected Conservative Premier Walter R. Shaw bluntly told the Potato Producers Association's annual meeting the growers should all get together and reach some unanimous decision on what they want. Divided among themselves, there are several elements each advancing a different type of proposal and all attempting to gain government support for their own project.

Preliminary Legal Rounds Continue In Election Issue

A notice of objection on behalf of George E. Saville of Annandale has been filed by J.O.C. Campbell, QC, with the Provincial prothonotary G.R. Holmes, it was announced yesterday. The notice is against the petition previously filed by C.R. MacQuaid on behalf of Leslie Hunter of Bridgetown, asking that the election of Mr. Saville be set aside.

Mr. Saville, representing the Liberal party was declared elected after the Kings County Sheriff east a deciding vote to break a tie which resulted between Hunter and Saville at the last provincial election.

Another Progressive Conservative candidate, Wellington MacNeill has filed a petition to have the election of his Liberal opponent Harold P. Smith set aside. Mr. Smith's majority over Mr. MacNeill was 22 votes. No objection was taken to Mr. MacNeill's petition within the required five days, it was stated. In the case of Mr. Campbell's objection, no date has as yet been set for a hearing.

Both petitions eventually will be heard in Supreme Court once preliminary objection and answers are dealt with. It was explained that no objections or answers need be filed to the original petition before it is set to come before the Supreme Court for a hearing. As yet no date has been set for the hearing of either petition.
