## SHERIFF'S SALE.

BY virtue of a writ of Statute Execution to me directed, issued out of Her Majesty's Supreme Court of Judicature, at the suit of John Lefurgy against James Craswell, deceased, late of Summerside, in Prince County, Prince Edward Island, I have taken and seized, as the property of the said James Craswell, deceased, in his lifetime, All the right, title and Freehold Interest which belonged to the said James Craswell, in his life time, and of which he died seized or possessed, in and to the following described pieces or parcels of land, viz :—Commencing at a stake fixed on the north-west angle of a Lot of Land willed by the late William Green to his wife, and now in the possession of Alexander Shaw; thence running north 30 deg. east 239 feet; thence 41 deg. 15 min. west 384 feet; thence south 30 deg. west 239 feet; thence south 41 deg. 15 min. east 384 feet, to the place of beginning, containing two acres, more or less.
